- 1.4. The annexation of said premises to the City of Montevideo is in the best interests of the City of Montevideo and of the territory to be annexed.

Pursuant to Minnesota Statute Section 414.033, Subd. 2, that certain tract of land in the County of Chippewa and State of Minnesota described on Exhibit A attached hereto and incorporated herein by reference is hereby annexed to the City of Montevideo and is incorporated into the corporate limits of the City and shall be zoned as HB, Highway Business. Beginning at a point on the east line of said Section 8, distant 24.5 feet north of the southeast corner thereof; thence run westerly at an angle of 90 degrees 44 minutes 00 seconds from said east section line (measured from north to west) for 1319.2 feet; thence deflect to the right at an angle of 23 degrees 19 minutes 00 seconds for 1709.8 feet and there terminating;
- Line 3. Beginning at a point on Line 2 described above, distant 888.7 feet southeasterly of its point of termination; thence run southwesterly at right angles to said Line 2 for 300 feet and there terminating.
