#### ORDINANCE NO. 59

AN ORDINANCE OF THE CITY OF DENNISON, MINNESOTA, EXTENDING THE CORPORATE LIMITS OF THE CITY OF DENNISON, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 60 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition by RONALD R. DETLIE and JACQUELINE J. DETLIE, husband and wife, DONALD W. KUNTZE, RICHARD F. KUNTZE, and PAUL S. HAGER requesting annexation of the territory hereinafter described was duly presented to the Council of the City of Dennison on the 5th day of July, 1994, pursuant to MSA 414.033, Subd. 2 (3); and

WHEREAS, the territory embraced within the area described in the petition and bounded as described is approximately 2.03 acres of unplatted land, located within Northfield Township, Rice County, Minnesota, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all of the owners of the said territory; and

WHEREAS, the territory described in the petition abuts upon the city limits at the west boundary thereof;

AND WHEREAS, the territory described in the petition is commercial territory deemed to be urban or suburban in character or about to become so.

NOW, THEREFORE, THE CITY OF DENNISON ORDAINS:

SECTION 1. The City Council hereby determines (1) that the petition of RONALD R. DETLIE and JACQUELINE J. DETLIE, husband and

wife, DONALD W. KUNTZE, RICHARD F. KUNTZE, and PAUL S. HAGER for the annexation of certain territory pursuant to MSA 414.033 Subd. 2(3) is in order and the annexation of such territory will be in the best interests of the City of Dennison and of the territory affected; (2) that the territory described herein consists of 2.03 acres, abuts upon the city limits on the west, is commercial in nature, and is now or is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

SECTION 2. TERRITORY ANNEXED. The corporate limits of the City of Dennison are hereby extended to include the unplatted territory described as follows and the same is hereby annexed to and included with the City of Dennison as effectually as if it had originally been a part hereof.

SECTION 3. FILING. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Town Clerk of Northfield Township, the Rice and Goodhue County Auditors and the Secretary of State.

SECTION 4. EFFECTIVE DATE. This ordinance shall take effect after publication and upon filing of the certified copies as directed in Section 3.




