RESOLUTION NO. 11-14-94-1  
RESOLUTION FOR ANNEXATION OF CERTAIN UNINCORPORATED PROPERTY TO THE CITY OF FOREST LAKE.

WHEREAS, the following described area in Forest Lake Township, Washington County, Minnesota abuts the corporate limits of the City of Forest Lake on its southerly side, to-wit:

- A. That part of the NW 1/4 of the NE 1/4 of Section 17, Township 32 North, Range 21 West described as follows, to-wit: Beginning at the NE corner of Registered Land Survey No. 35; thence North along the East line of Registered Land Survey No. 35 extended North to the North line of Section 17; thence East along the North line of Section 17 to the East line of the Burlington Northern Railroad right-of-way; thence South along the East line of the Burlington Northern Railroad right-of-way a distance of 66 feet; thence Westerly to the point of beginning.
- B. That part of the NW 1/4 of the NE 1/4 of Section 17, Township 32 North, Range 21 West lying north of Registered Land Survey No. 35.
- C. That part of Government Lot 2, Section 17, Township 32 North, Range 21 West, except the West 300 feet thereof, lying north of Registered Land Survey No. 35.
- D. The North 33 feet of the West 300 feet of Government Lot No. 2, Section 17, Township 32 North, Range 21 West.
- E. The North 33 feet of Government Lot 1, Section 17, Township 32 North, Range 21 West.
- F. The North 33 feet of Government Lot 2, Section 18, Township 32 North, Range 21 West.
- G. The North 33 feet of the East 33 feet of Government Lot 3, Section 18, Township 32 North, Range 21 West.

WHEREAS, said property is urban or suburban in nature or is about to become so, and

WHEREAS, the property lies primarily within the S 1/2 of the right-of-way of Washington County Highway No. 83 in part known as 11th Avenue SW, and

WHEREAS the City of Forest Lake is capable of providing immediate services to this area, and

WHEREAS, the Town of Forest Lake may have certain utility easements within the property, and

WHEREAS, it is in the best interest of the area and the City of Forest Lake that it be annexed to the City of Forest Lake, and

WHEREAS, the area to be annexed contains approximately 3.5 acres, and


