RESOLUTION OF TOWN BOARD OF RHINEHART TOWNSHIP, POLK COUNTY, MINNESOTA WAIVING OBJECTION TO ANNEXATION

Supervisor Lyle Smth seconded by Supervisor R. chard Andurson introduced the following Resolution and moved its adoption:

WHEREAS, certain lands and real property described below are not presently within the corporate limits of any incorporated city, village or burrow, said lands and real property being situated in the Township of Rhinehart, County of Polk and State of Minnesota, described as follows, to-wit:

That part of the Southwest and the Southeast Quarters of the Southeast Quarter, Section 12, Township 151 North, Range 50 West of the 5th Principal Meridian, lying South of Robertson Subdivision and West of Woodland Park Subdivision according to the recorded plats thereof to the City of East Grand Forks, Polk County, Minnesota, described as follows:

Commencing at the southwest corner of said Southeast Quarter; thence easterly along the south line of said Section 12 having an assumed bearing of South 89 degrees 54 minutes 20 seconds East a distance of 660.59 feet to the point of beginning; thence continuing South 89 degrees 54 minutes 20 seconds East along the south line of said Section 12 a distance of 1122.34 feet to the southwest boundary corner of said Woodland Park Subdivision; thence North 00 degrees 05 minutes 03 seconds West along the west boundary line of said Woodland Park Subdivision a distance of 784.42 feet to the south line of said Robertson Subdivision; thence North 89 degrees 51 minutes 32 seconds West along the south line of said Robertson Subdivision a distance of 1121.04 feet to the southwest boundary corner of said Robertson Subdivision; thence South 00 degrees 00 minutes 39 seconds West along the southerly extension of the west line of said Robertson Subdivision a distance of 785.34 feet to the point of beginning. Containing 20.21 acres more or less; and

WHEREAS, Robert E. Peabody and Jeanine H. Peabody, husband and wife, have executed and filed a Petition for Annexation of the above-described tract of land to the City of East Grand Forks, Minnesota; and

WHEREAS, said land abuts upon the corporate limits of the City of East Grand Forks, Minnesota, thereof and is deemed to be urban and

That the Town Board of the Township of Rhinehart, Polk County, Minnesota, acting on behalf of said Township of Rhinehart, does hereby waive any and all objections that said Township may have in regard to the above-described annexation and we hereby further waive any further notices in regard to said annexation, except those notices required by Statute.
