## ORDINANCE NO. 249, 2ND SERIES

AN ORDINANCE OF THE CITY OF THIEF RIVER FALLS, MINNESOTA, AMENDING CITY CODE CHAPTER 20 ENTITLED "LISTING OF UNCODED ORDINANCES IN EFFECT" BY EXTENDING THE CORPORATE LIMITS OF THE CITY OF THIEF RIVER FALLS TO INCLUDE UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 60 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, A certain petition dated March 6th, 1995, requesting annexation of the territory hereinafter described was duly presented to the Thief River Falls City Council, and

WHEREAS, No objections to the annexation have been received from the North Town Board, and

WHEREAS, The territory described herein abuts upon the City limits and is urban or suburban in character and none of the territory is now included within the limits of any city, and

WHEREAS, The approximate population of this territory is less than 50.

THE CITY COUNCIL OF THIEF RIVER FALLS ORDAINS:

Section 1. City Code Chapter 20 entitled "Listing of Uncoded Ordinances In Effect" is hereby amended by adding this section to read:

Territory Annexed. The corporate limits of the City of Thief River Falls are hereby extended to include the unplatted territory described as follows and the same is hereby annexed to and included within the City of Thief River Falls as effectually as if it had originally been a part thereof:

See attached Exhibit "A".

Section 2. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the North Town Clerk, and the Pennington County Auditor.

Section 3. This ordinance shall be in force and effect from and after its passage, approval, and publication and approval by the Minnesota Municipal Board.




## **DESCRIPTION:**

Commencing at an iron monument at the southeast corner of said Section 27; thence North 01 degrees 42 minutes 22 seconds East, assumed bearing, along the east line of said Section 27 a distance of 1321.79 feet to an iron pipe monument at the northeast corner of the Southeast Quarter of the Southeast Quarter of said Section 27; thence North 89 degrees 25 minutes 37 seconds West, along the north line of the said Southeast Quarter of the Southeast Quarter a distance of 1319.32 feet to an iron pipe monument at the southeast corner of the said Northwest Quarter of the Southeast Quarter, being the point of beginning of the tract to be described; thence continuing along the south line of the said Northwest Quarter of the Southeast Quarter a distance of 647.23 feet to an iron pipe monument; thence North 01 degrees 42 minutes 22 seconds East, parallel with the east line of the said Southeast Quarter of Section 27 a distance of 450.00 feet to an iron pipe monument; thence Southeast Quarter a distance of 647.37 feet to an iron pipe monument of the Southeast Quarter of the Southeast Quarter of the Southeast Quarter of the south 89 degrees 25 minutes 37 seconds East, parallel with the south 100 feet to an iron pipe monument; thence Southeast Quarter a distance of 647.37 feet to an iron pipe monument of the Southeast Quarter of the Southeast Quarter; thence South 01 degrees 43 minutes 24 seconds West along said east line 450.00 feet to the point of beginning, containing 6.69 acres, more or less.
