PETITION FOR ANNEXATION
TO THE CITY COUNCIL OF THIEF RIVER FALLS, MINNESOTA

We, the undersigned, owners of the properties listed following our names, hereby request that the City Council annex these properties to the City of Thief River Falls and extend the Corporate Limits of the City to include the same, and for that purpose respectfully state:

1. The properties to be annexed consist entirely of platted lands not exceeding 200 acres in area. All of these lands lie entirely within the County of Pennington, Minnesota, and are part of Nelson's First Addition.

2. The territory described below abuts upon the Corporate Limits at the easterly boundary thereof and none of it is presently included within the corporate limits of any incorporated city.

3. All of this territory is or is about to become urban or suburban in character.

4. The population of the area is not stated by Petitioners.

5. The property owners required to constitute a sufficient petition under M.S. 414.033, Subd. 5., are requesting the annexation.
