AN ORDINANCE PROVIDING FOR THE ANNEXATION OF LAND OWNED BY THE CITY OF RUSH CITY AND ABUTTING THERETO BY ADDING "SECTION XII. ANNEXATION BY ORDINANCE" TO THE RUSH CITY CODE.

Section XII. Annexation By Ordinance
Part 1. Airport and Lagoon Property
Section 1201.01. The City of Rush City presently owns the following described unincorporated land abutting the Rush City limits all of which lies within the County of Chisago, State of Minnesota,
A. The following parcel lies in Section 10, Township 37, Range 21
a. The Southeast $1 / 4$ of the Southwest $1 / 4$ of the Southwest $1 / 4$ and the West 400 feet of the South $1 / 2$ of the Southeast $1 / 4$ of the Southwest $1 / 4$.

B. The following parcels all lie in Section 15, Township 37, Range 21

Section 1201.02. The past, present, and planned future use of the parcels described herein is for the operation of the Rush City Regional Airport and the Rush City Wastewater Treatment Plant.

Section 1201.03. Inclusion of these parcels within the corporate boundaries of Rush City will facilitate funding of airport and wastewater treatment improvements.

Section 1201.04. Upon adoption of this ordinance, the land described herein shall be annexed to the City of Rush City, a municipal corporation, and be included in the corporate limits thereof as per Minnesota Statutes Section 414.033 Subd. 1. and Subd. 2. (1)

Section 1201.05. Immediately upon adoption, certified copies of this ordinance shall be filed as provided in Minnesota Statutes Chapter 414 and all other applicable sections thereto shall be complied with.

Section 1201.06. There are no residences on the parcels described herein nor is there any resident population as of this date.
