# ORDINANCE NO. 95-6

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF PELICAN RAPIDS TO INCLUDE CERTAIN LAND OWNED BY THE CITY OF PELICAN RAPIDS AND ABUTTING THE CITY LIMITS OF PELICAN RAPIDS

WHEREAS, the City of Pelican Rapids owns the following described property:

The North 1/2 of the Northeast 1/4 of Section 34, Township 136 North, Range 43 West, Otter Tail County, Minnesota.

and;

WHEREAS, the City of Pelican Rapids owns the property, the property is unincorporated, abutts the limits of the City of Pelican Rapids, is not included within any other municipality, is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes §414.0325, and is approximately 80 acres in size.

NOW THEREFORE, the City Council of Pelican Rapids does hereby ordain:

- **Section 1**. The City Council hereby determines and finds that the property abutts the municipality, that the property is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes §414.0325, that the municipality owns the property to be annexed, and that all of the provisions of Minnesota Statutes §414.033 have been complied with.
- **Section 2**. The property is urban in nature or about to become so, and will be used mainly for industrial, commercial and residential purposes.
- **Section 3**. The corporate limits of the City of Pelican Rapids are hereby extended to include the property and the same is hereby declared to be annexed to and included within the City of Pelican Rapids as if the property had originally been a part thereof.
- **Section 4**. The City Clerk is directed to file certified copies of this ordinance with the Minnesota Municipal Board, Pelican Township, the Otter Tail County Auditor and the Minnesota Secretary of State.
- **Section 5**. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4 and approval of the ordinance by the Minnesota Municipal Board.

- **Section 5**. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4 and approval of the ordinance by the Minnesota Municipal Board.






