AN ORDINANCE ANNEXING TO THE CITY OF WINSTED, MINNESOTA CERTAIN LANDS IN WINSTED TOWNSHIP ABUTTING THE CITY, BEING OWNED BY THE CITY OF WINSTED.

THE CITY COUNCIL OF WINSTED DOES ORDAIN:

Section 1. The City of Winsted having received the Petition of CITY OF WINSTED, a Municipal Corporation, is the owner of certain lands as per attached Exhibits "A", "B", "C" and "D", which are incorporated herein by reference as though fully set forth in full, which abut upon the present territorial limits of the City of Winsted, and the City Council of the City of Winsted desires to annex such lands so as to include said lands within the City of Winsted, County of McLeod and State of Minnesota and to further adopt an Ordinance annexing said land to the City of Winsted. Such parcel of land is located in Winsted Township, McLeod County, Minnesota and is described as per attached Exhibits "A", "B", "C" and "D" which are incorporated herein by reference as though fully set forth in full.

The Mayor and the Council of the City of Winsted do hereby determine Section 2. that the land described in Section 1 above abuts upon the present territorial limits of the City of Winsted, and is urban in character, and the annexation of said land will be to the best interest of the City of Winsted and the territory affected.

Section 3. Therefore, the lands referred to in Section 1 above and legally described in Section 1 above, are hereby annexed, added to and made a part of the City of Winsted, as effectually as if it had originally been a part thereof.

This Ordinance shall take effect and be in force from and after its official Section 4. publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Board, the Clerk of Winsted Township, the McLeod County Auditor and the Secretary of State of Minnesota.
