

ANNEXATION ORDINANCE

Ordinance No. 42A

AN ORDER AMENDING ORDINANCE NO. 42 RELATING TO ANNEXATION OF LANDS.

The City Council of the City of Jenkins, Minnesota, does hereby ordain:

SECTION I.

Ordinance No. 42 is hereby amended to correct a clerical error so that the legal description on page 2 thereof reads as follows:

That part of the Southeast Quarter of the Northwest (SE 1/4 NW 1/4), Section Three (3), Township One Hundred Thirty-six (136) North, Range 29 West, Crow Wing County, Minnesota, lying Westerly of the Westerly right-of-way line of State Trunk Highway Number 371, lying Easterly of the Easterly right-of-way line of the State of Minnesota Paul Bunyan Trail, formerly known as the Burlington Northern Railroad and lying Southerly of the North 568.00 feet of said Southeast Quarter of the Northwest Quarter. And those parts of the Southwest Quarter of the Northeast Quarter (SW 1/4 NE 1/4), Government Lot Three (3), and the Southeast Quarter of the Northwest Quarter (SE 1/4 NW 1/4), said Section Three (3), described as follows: Commencing at the Southeast corner of said Government Lot 3; thence North 0 degrees 39 minutes 01 seconds West, assumed bearing along the East line thereof 632.24 feet to the point of beginning of the tract to be herein described, thence South 88 degrees 21 minutes 34 seconds West 356.01 feet; thence South 0 degrees 39 minutes 01 seconds East 74.07 feet; thence South 8 degrees 06 minutes 45 seconds East 619.69 feet; thence South 38 degrees 47 minutes 52 seconds East 831.98 feet; thence South 40 degrees 38 minutes 16 seconds East 66.00 feet; thence North 88 degrees 45 minutes 12 seconds East 1084.15 feet to the East line of said Southwest Quarter of the Northeast Quarter (SE 1/4 NE 1/4); thence South 0 degrees 59 minutes 13 seconds East along last said East line 577.34 feet to the Southeast corner of said Southwest Quarter of the Northeast Quarter; thence South 88 degrees 45 minutes 12 seconds West 1119.86 feet, more or less, to the Easterly right-of-way line of State Trunk Highway Number 371; thence Northwesterly along said Easterly right-of-way line to the North line of said Government Lot 3; thence Easterly along said North line 1203.37 feet, more or less, to the Northeast corner of said Government Lot 3; thence South 0 degrees 39 minutes 01 seconds East along the East line of said Government Lot 3 a distance of 378.44 feet, more or less, to the point of beginning. Containing 50.01 acres.

SECTION II.

All other provisions of Ordinance No. 42 shall remain the same.

SECTION III.

This Ordinance shall be in full force and effect from and after its passage and publication according to law.

SECTION IV.

The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, Secretary of State, the Township Clerk and the County Auditor.

SECTION V.

This Ordinance takes effect upon its passage and publications and the filing of the certified copies as directed in Section IV. and the approval of the ordinance by the Minnesota Municipal Board.
