CITY OF RANIER ORDINANCE NO. 110

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF RANIER TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND, NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated May 22, 1996, requesting annexation of the territory hereinafter described was duly presented to the council on the 28th day of May, 1996; and

WHEREAS, the petition was signed by all owners; and

> WHEREAS, no objections to the annexation have been received from the town board, or the government body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

> WHEREAS, the land described in the petition abuts upon the city limits at the western boundary thereof;

The council of the City of Ranier, Minnesota, ordains:

Section 1. The city council hereby determines (1) that the territory described herein abuts upon the city limits and is urban or suburban in character; and

(2) that none of the territory is now included within the limits of any city.

Section 2. The population of the territory is 2.

Section 3. Territory annexed. The corporate limits of the city are hereby extended to include the platted land located in Koochiching County, Minnesota, described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Plat of Riverside Park, Block 1, Lots 1 and 2, Parcel ID #22-58-01010

Section 4, Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 5. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.

In the matter of the Petition of Certain Persons, or for annexation pursuant to Minnesota Statutes, section 414.033, Subdivision 5.

TO THE COUNCIL OF THE CITY OF RANIER, MINNESOTA:
