WHEREAS, it is the desire of the City of McKinley to annex said abutting land to the corporate limits of the City.

<u>Section 4</u>. The City Clerk is directed to file certified copies of this ordinance with the Minnesota Municipal Board, Biwabik Township, the St. Louis County Auditor and the Minnesota Secretary of State.

<u>Section 5</u>. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4 and approval of the Ordinance by the Minnesota Municipal Board.


