PETITION FOR ANNEXATION OF CERTAIN
TOWN OF LA CRESCENT LANDS TO THE CITY OF LA CRESCENT
UNDER SECTION 414.033 SUBDIVISION 5, MINNESOTA
GENERAL STATUTES

TO: CITY COUNCIL, CITY OF LA CRESCENT.

The undersigned, being a majority of the property owners in number of the lands the subject matter of this Petition for their Petition, state and allege:

1. That the lands sought to be annexed are partly platted and in part unplatted.

2. That the total area of the lands sought to be annexed does not exceed 200 acres; is approximately 133 acres.

3. That the lands proposed to be annexed are now or are about to become urban or suburban in character.

4. Unless the undersigned are ALL of the owners of the lands proposed to be annexed, Petitioners understand that Hearing on the within proposed annexation preceded by 30 days mailed notice to all property owners of the land to be annexed must be held by the City Council.

5. Lands proposed to be annexed abut on the City limits of the City of La Crescent and are not presently served by public sewer facilities nor are public sewer facilities otherwise available to said lands.

6. The lands, the subject matter of this Petition, are commonly known as that part of Shore Acres of the Town of La Crescent lying westerly of the west bank of the Mississippi River, easterly of the present City of La Crescent corporate limits, northerly of the north line of the present corporate limits of the City of La Crescent, said property is more

particularly described as follows, to-wit:

All those lands being parts of the North half of the Southwest Quarter and of the Southwest Quarter of the Northwest Quarter of Section 2 and of the Northeast Quarter and that part of the North Half of the Southeast Quarter of Section 3, all in Township 104 North of Range 4 West of the Fifth Principal Meridian lying and being Westerly of the water's edge of the Mississippi River and Easterly of the present Easterly Corporate limits and Northerly of the present Corporate limits of the City of La Crescent.
