## ORDINANCE NO. 134

## ANNEXATION OF CERTAIN PROPERTY IN THE CITY LIMITS OF STARBUCK.

WHEREAS, the City of Starbuck has been presented with a Petition signed by all of the property owners of the property described on Exhibit "A" attached hereto seeking to have said property annexed into the city limits of Starbuck pursuant to Minnesota Statutes 414.033, Subd. 5; and

WHEREAS, said property is unincorporated, is not a part of any other municipality and abuts the city limits of the City of Starbuck; and

WHEREAS, said property now lies in the Township of White Bear Lake and the town board of said township has consented to the annexation; and

WHEREAS, the subject property is approximately 17 acres in size; and

WHEREAS, the Minnesota Municipal Board has given its approval to the annexation;






