## ORDINANCE NO. 292

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MADISON TO INCLUDE CERTAIN UNINCORPORATED LANDS BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, certain lands described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, certain lands abut the municipality and the area to be annexed is 60 acres or less and the area to be annexed is not presently served by public sewer facilities or public sewer facilities are not otherwise available and the municipality received a petition for annexation from all of the property owner(s) of land to be annexed and is deemed to be urban or suburban in character;

The City Council of the City of Madison does ordain:

SECTION 1. <u>LANDS ANNEXED</u>. The corporate limits of the City of Madison, Minnesota, are hereby extended to include the unplatted lands described as follows, That part of the Northwest Quarter (NW½), Section Twenty-eight (28), Township One Hundred Eighteen (118) North, of Range Forty-four (44) West lying south of the Lac qui Parle Railroad Authority property less the south 80 acres thereof, said tract consisting of 40.75 acres, more or less. which is 60 acres or less and the area to be annexed is not presently served by public sewer facilities or public sewer facilities are not otherwise available and the municipality received a petition for annexation from all of the property owner(s) of land to be annexed and is deemed to be urban or suburban in character;

SECTION 2. <u>FILING</u>. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the Lac qui Parle county Auditor, the Madison Town Clerk and the Minnesota Municipal Board.

SECTION 3. <u>EFFECTIVE DATE OF ANNEXATION</u>. This ordinance takes effect 30 days after passage and publication and the filing of certified copies as directed in Section 2 and approval by the Minnesota Municipal Board.
