

**ORDINANCE NO. 423  
2<sup>ND</sup> SERIES**

**AN ORDINANCE AMENDING ORDINANCE NO. 394, 2<sup>ND</sup> SERIES, FOR THE  
PURPOSES OF MORE PARTICULARLY DESCRIBING THE TERRITORY TO BE  
ANNEXED**

**WHEREAS**, the City Council of the City of Alexandria did, on January 13, 1997, adopt Ordinance No. 394, thereby annexing property to its corporate limits, and

**WHEREAS**, said Ordinance was transmitted to the Minnesota Municipal Board for its review and distribution to other agencies of the State of Minnesota, and

**WHEREAS**, the Minnesota Department of Transportation has requested a revised legal description of the territory to be annexed, and

**WHEREAS**, the City has revised said legal description and received approval from the Minnesota Department of Transportation for said revisions,

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ALEXANDRIA  
HEREBY ORDAINS:**

**SECTION I.** That Ordinance No. 394, Second Series is hereby amended by deleting all of Section II of said Ordinance No. 394 and replacing it with the following:

**SECTION II.** This territory consists of platted and unplatted land in Douglas County containing approximately 88.2 acres in two parcels which are described as the:

Northeast Quarter of the Northeast Quarter of Section 13, Township 128 North, Range 38 West in LaGrande Township (PIN 27-0614-000 @ 40 Ac.)

and

All of Government Lot 1 lying West of Lunz Supplement to Henry Beach and all of the SW  $\frac{1}{4}$  NW  $\frac{1}{4}$  lying Northeasterly and Easterly of County State Aid Highway No. 37 and Northwesterly of Kloehn's Subdivision; all in Section 18, Township 128, Range 37.

and

That part of County State Aid Highway No. 37 being in said SW  $\frac{1}{4}$  NW  $\frac{1}{4}$  lying Northwesterly and Northerly of a line described as follows: Beginning at the Northwesterly corner of Lot 1, Block 1, Kloehn's Subdivision according to the recorded plat thereof; thence south 43 degrees 00 minutes West, assumed bearing along the Southwesterly extension of the Northeasterly line at said Lot 1 at a distance at 66.00 feet to the intersection with the Southwesterly right-of-way line of said County State Aid Highway No. 37 and said line there terminating.

and

That part of Government Lot 1 lying West of Lunz Supplement to Henry Beach, and that part of the SW  $\frac{1}{4}$  NW  $\frac{1}{4}$  lying Northeasterly and

Easterly of County State Aid Highway No. 37 and Northwesterly of Kloehn's Subdivision, all in Section 18, Township 128 North, Range 37 West in Alexandria Township.

and

That part of said County State Aid Highway No. 37, being in said SW ¼ NW ¼ of said Section 18, Alexandria Township, lying Northwesterly and Northerly of a line described as follows:

Beginning at the Northwesterly corner of Lot 1, Block 1, said Kloehn's Subdivision, according to the recorded plat thereof; thence South 43 degrees 00 minutes West, assumed bearing, along the Southwesterly extension at the Northwesterly line of said Lot 1, a distance of 66.00 feet, to the intersection with the Southwesterly right-of-way line of said County State Aid Highway No. 37 and said line there terminating.

SECTION II. This Ordinance shall be in full force and effect from and after its passage and publication.


