IN THE MATTER OF THE PETITION FOR ANNEXATION OF  
UNINCORPORATED ADJOINING PROPERTY LOCATED ALONG VAN DYKE ROAD  
ALEXANDRIA, MINNESOTA.

**TO THE CITY OF ALEXANDRIA AND THE MINNESOTA MUNICIPAL  
BOARD:**

WE, THE UNDERSIGNED, the owners of the property described below, hereby petition  
the Alexandria City Council to annex this territory to the City of Alexandria, Minnesota and for  
that purpose respectfully state:

1. The petitioners are the owners of the subject property.
2. Pursuant to Minn. Stat. Section 414.022, Subdivision 5, the petition is a majority of  
the property owners within the affected area.
3. The property currently abuts upon the northerly boundaries of the Alexandria City  
Limits along the southerly boundary of the subject property and is not presently a part  
of any incorporated city.
4. This property consists of platted land in Alexandria Township, Douglas County,  
containing approximately 18.53 acres in 25 parcels owned by 33 property owners  
which is described as:
