RESOLUTION ACCEPTING PETITION FOR ANNEXATION

The South-east quarter of the South-east quarter ($SE\frac{1}{4}$ of $SE\frac{1}{4}$) Section Ten (10) Township Thirty-six (36) North of Range Thirty-one (31) West of the fourth principal meridian.

AND:

Northeast Quarter of Southeast Quarter ($NE\frac{1}{4}$ of $SE\frac{1}{4}$) and Southeast Quarter of Northeast Quarter ($SE\frac{1}{4}$ of $NE\frac{1}{4}$) all in Section Ten (10), Township Thirty-six (36), North of Range Thirty-one (31), West of the Fourth Principal Meridian.

BE IT FURTHER RESOLVED: That the administrator-Clerk shall forward a copy of the petition and this resolution to the Minnesota Municipal Board, the Sauk Rapids Town Board, and the Benton County Board of Commissioners.

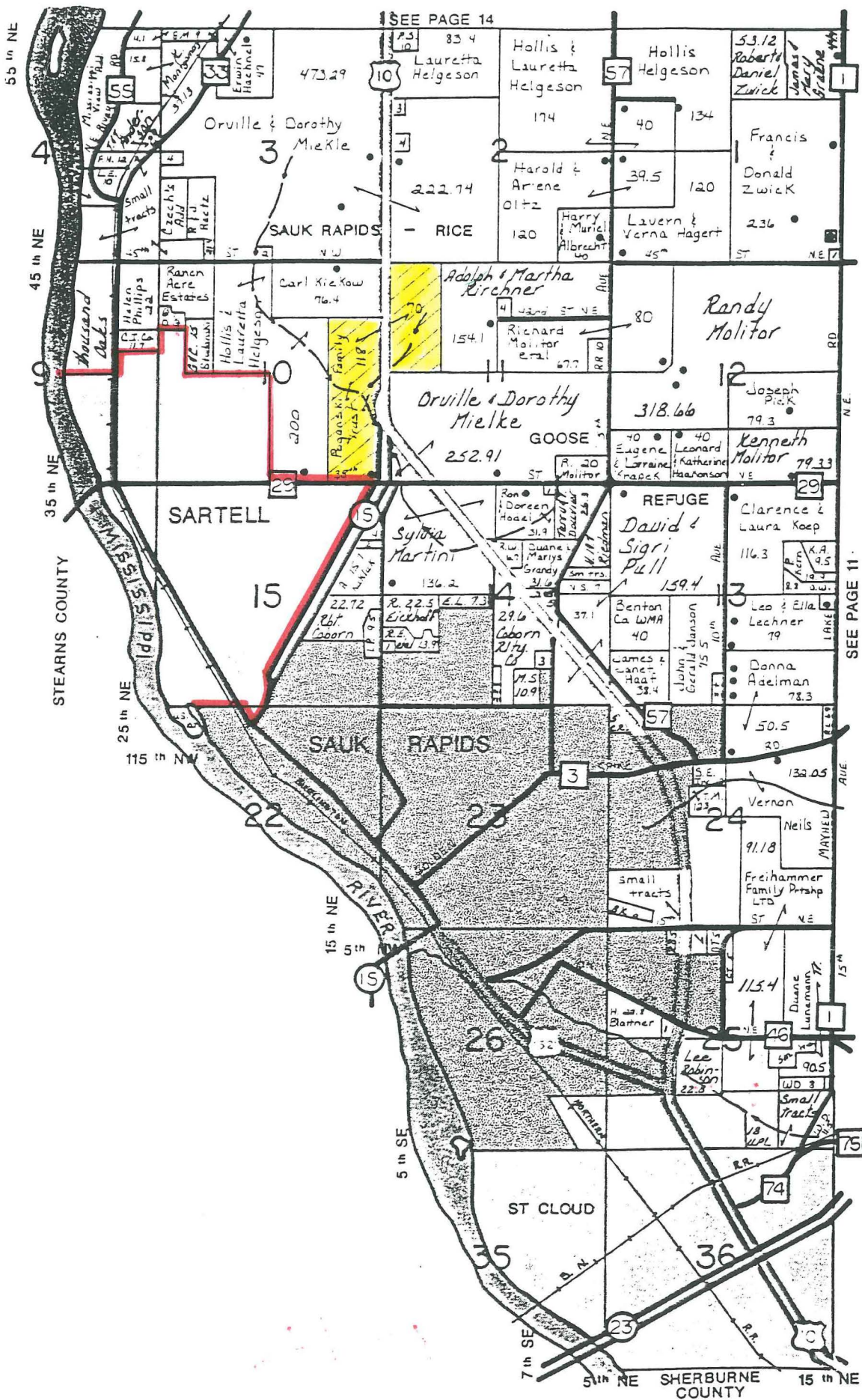
