CITY OF WINTHROP ORDINANCE NUMBER 210

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINTHROP TO INCLUDE CERTAIN UNINCORPORATED AND UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS (ARLIN AND BETH MILLER)

WHEREAS, A CERTAIN PETITION DATED JUNE 26, 1997, HEREINAFTER DESCRIBED WAS DULY PRESENTED TO THE CITY COUNCIL ON THE 7TH DAY OF JULY, 1997; AND

WHEREAS, THE PETITION WAS SIGNED BY ALL OWNERS; AND

WHEREAS, NO OBJECTIONS TO THE ANNEXATION HAVE BEEN RECEIVED FROM THE TOWN BOARD, OR THE GOVERNMENT BODY OF ANY MUNICIPALITY WHOSE BOUNDARIES ABUT UPON THE BOUNDARIES OF THE LAND TO BE ANNEXED' AND

WHEREAS, THE LAND DESCRIBED IN THE PETITION BUTS UPON THE CITY LIMITS AT THE SOUTH BOUNDARY THEREOF.

NOW, THEREFORE, THE CITY COUNCIL ORDAINS:

SECTION I. THE CITY COUNCIL HEREBY DETERMINES (1) THAT THE TERRITORY DESCRIBED HEREIN ABUTS UPON THE CITY LIMITS AND IS ABOUT TO BECOME URBAN OR SUBURBAN IN CHARACTER; AND (2) THAT NONE OF THE TERRITORY IS NOW INCLUDED WITHIN THE LIMITS OF ANY CITY.

SECTION II. THE POPULATION OF THE TERRITORY IS FIVE.

SECTION III. TERRITORY ANNEXED. THE CORPORATE LIMITS OF THE CITY ARE HEREBY EXTENDED TO INCLUDE THE UNPLATTED LAND DESCRIBED IN ATTACHMENT "A" AND THE SAME IS HEREBY ANNEXED TO AND INCLUDED WITHIN THE CITY AS EFFECTUALLY AS IF IT HAD ORIGINALLY BY A PART THEREOF.

SECTION IV. FILING. THE CITY CLERK IS HEREBY DIRECTED TO FILE CERTIFIED COPIES OF THIS ORDINANCE WITH THE MINNESOTA MUNICIPAL BOARD, THE SECRETARY OF

STATE, THE ALFSBORG TOWN CLERK, AND THE SIBLEY COUNTY AUDITOR.

SECTION V. EFFECTIVE DATE. THIS ORDINANCE TAKES EFFECT UPON ITS PASSAGE AND PUBLICATION AND THE FILING OF THE CERTIFIED COPIES AS DIRECTED IN SECTION 3, AND APPROVAL OF THE ORDINANCE BY THE MINNESOTA MUNICIPAL BOARD.


