ORDINANCE NO. 97-12

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ROCKFORD TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND 12.30 ACRES IN AREA ABUTTING THE CITY LIMITS PURSUANT TO MINN. STAT. 414.033

(PORTION OF FISKE'S ADDITION)

WHEREAS, the owners of certain hereinafter described Property notified the City on or about May 18, 1996 of their intent to petition for annexation, in accordance with Minn. Stat. 414.033, Subd. 13; and,

WHEREAS, the Property to be annexed consists of two parcels legally described as:

Parcel 1:

Lot 6, Block 1, Fiske's Addition, according to the plat of record, except the North 174.24 feet thereof, Property Identification Number: 215-020-001060; and,

Parcel 2:

Lot 7, Block 1, Fiske's Addition, according to the plat of record, Property Identification Number: 215-020-001070; and,

WHEREAS, the City notified the owners at a meeting at City Hall in April 1997, that the

cost of electric utility services may change if the Property were annexed to the City, which notice

included an estimate of the cost impact of any change in electric utility services, including rate

changes and assessments, resulting from the annexation, in fulfillment of the City's obligation

pursuant to Minn. Stat. 414.033, Subd. 1a; and,

WHEREAS, a Petition requesting annexation of the Property and signed by all owners was received by the Council on the 27th day of May 1997; and,

WHEREAS, a public hearing on the proposed annexation was held on July 8, 1997, by the

City Council following at least 30 days' notice by certified mail to the Town Board and to all persons entitled to notice; and,

WHEREAS, no valid objection to the annexation has been received;

NOW, THEREFORE, the Council of the City of Rockford, Minnesota, ordains:

Section 1. <u>Character of Property</u>. The City Council determines (1) that the Property abuts the City limits, is urban or suburban in character, and is ripe for development for commercial or light industrial uses; (2) that none of the Property is now included within the limits of any incorporated city, nor of any agricultural preserve; and (3) that the Property is not presently served by public sewer facilities and public sewer facilities are not otherwise available.

Section 2. <u>Population</u>. The population of the Property is four persons.

Section 3. <u>Property Annexed</u>. The corporate limits of the City are extended to include the Property. The Property is annexed into and included within the City as if it had originally been a part of the City.

Section 4. <u>Filing</u>. The City Clerk is directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 5. <u>Effective Date</u>. This Ordinance shall take effect upon its passage and publication and the filing of the certified copies as directed in Section 4, and approval of the Ordinance by the Minnesota Municipal Board.






