ORDINANCE # 281

AN ORDINANCE ANNEXING LAND IN THE SOUTHWEST QUARTER OF SECTION 1, TOWNSHIP 139, RANGE 35

STRAIGHT RIVER TOWNSHIP, HUBBARD COUNTY, MINNESOTA AND ADJOINING THE CITY OF PARK RAPIDS ON ITS SOUTHERN AND EASTERN BOUNDARY LINE

PURSUANT TO MINNESOTA STATUTES 414.033, SUBD. 2, (3), PERMITTING ANNEXATION BY ORDINANCE

THE COUNCIL OF THE CITY OF PARK RAPIDS HEREBY ORDAINS:

- 1. A petition was filed by R. D. Offutt as President of RDO Frozen Company of Delaware, a Delaware corporation, requesting the annexation of a tract of land in the Southwest Quarter of Section 1, Township 139, Range 35, and abutting the city limits of the City of Park Rapids on its southern and eastern border.
- 2. The petition was received by the City Council of the City of Park Rapids and a public hearing was scheduled in conformance with Minnesota Statutes 414.033, Subd. 2b for July 14, 1997.
- 3. That notice by certified mail was given to Straight River Township and to all landowners contiguous to the area to be annexed.
- 4. The public hearing was held on July 14, 1997, at 8:00 p.m. in the Park Rapids City Hall, Park Rapids, MN, and at the close of the public hearing, this ordinance was adopted.
- 5. That the map identifying the parcel is made a part of this ordinance together with the legal description therefor.

NOW THEREFORE, be it resolved:

- SECTION 1. That the unincorporated land located in the Southwest Quarter of Section 1, Township 139, Range 35, Straight River Township, Hubbard County, Minnesota, abuts the limits of the City of Park Rapids, is not ow included within the limits of the any city, is 8.26 acres in size, is or is about to become urban and suburban in character, and 100% of all owners of property within the described area have signed a petition requesting the property be annexed to the City of Park Rapids.
- SECTION 2. That the corporate limits of the City of Park Rapids are hereby extended to include the unplatted land described in this ordinance and the same is hereby annexed to be included within the City of Park Rapids, Minnesota, containing 8.26 acres.
- SECTION 3. The City Administrator is hereby directed to file certified copies of this ordinance with the Minnesota Municipal
