Section 31, lying northerly of the South 660 feet thereof and  
all of the Southwest Quarter of the Northwest Quarter of  
Section 32, both in Township 34 North, Range 19 West, Chisago  
County, Minnesota.

Subject to and together with any valid easements, restriction  
and reservations

This ordinance shall be effective upon publication in the  
Chisago County Press and approval by the Minnesota Municipal Board.

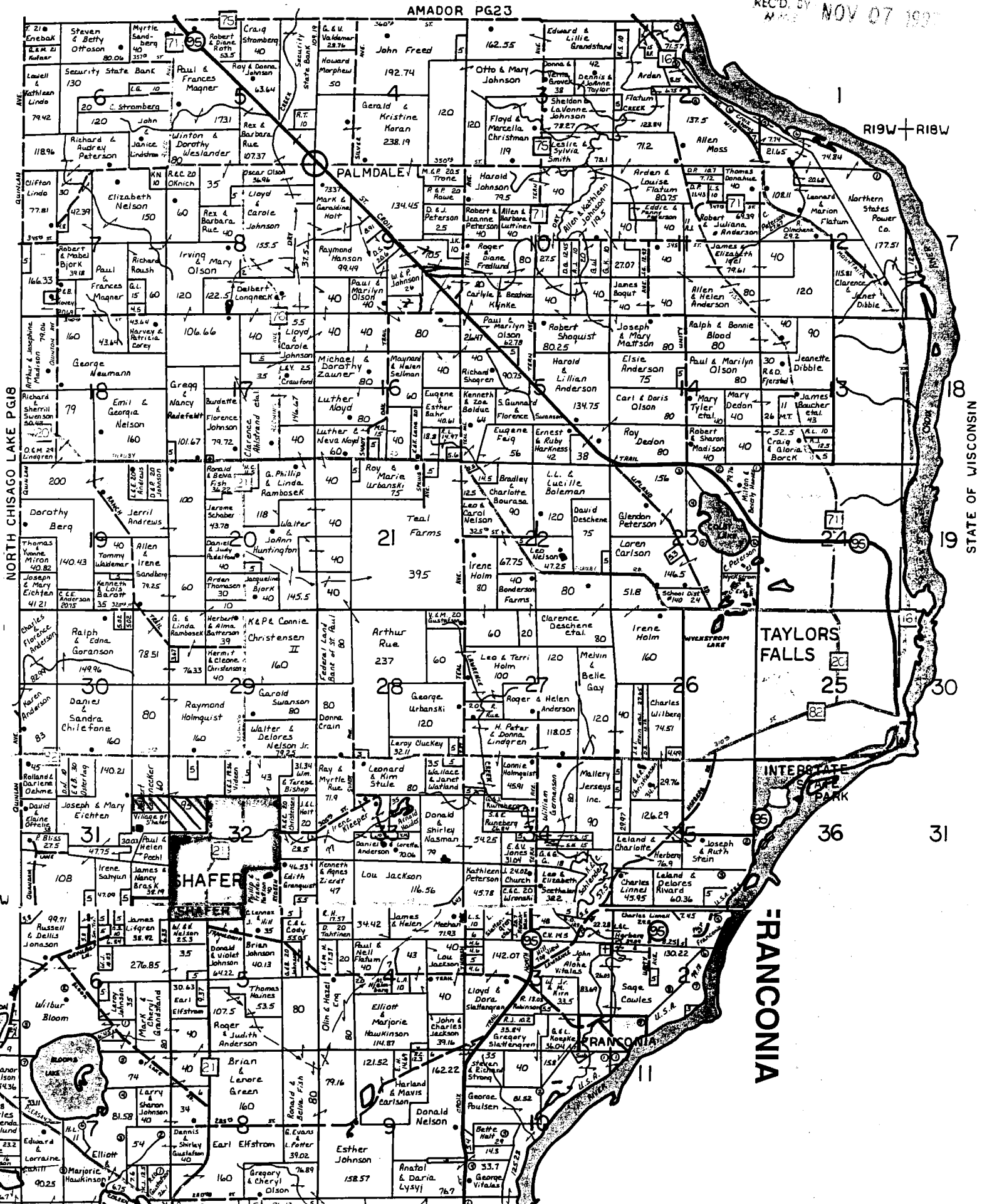

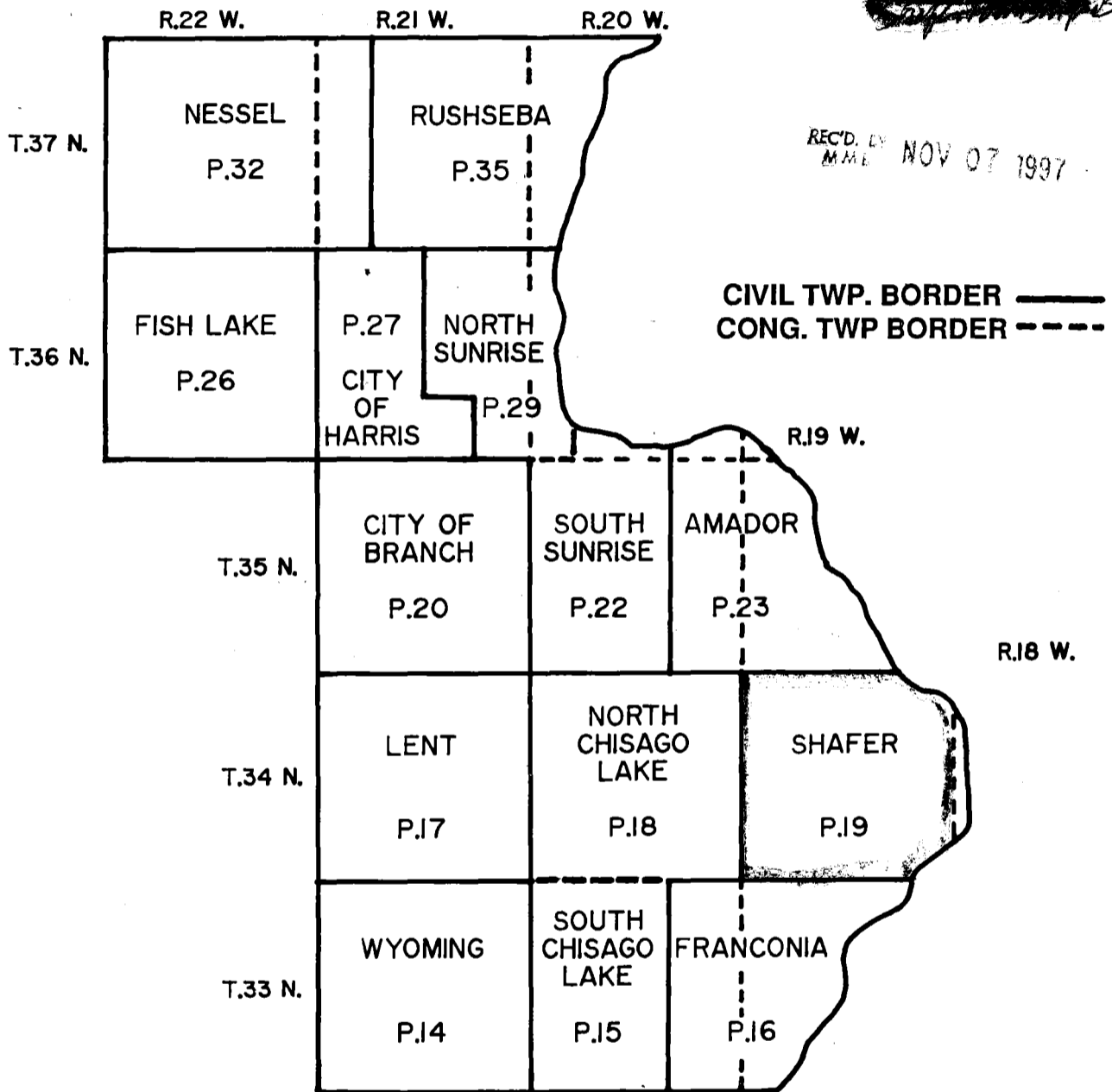
## Proposed Annexation Area
