# ORDINANCE NO. <u>5% 050(1)</u> AMENDING ORDINANCE 51.050 EXTENDING THE CORPORATE LIMITS OF THE CITY OF ELGIN TO INCLUDE CERTAIN UNINCORPORATED LAND ABUTTING THE CITY OF ELGIN

WHEREAS, the City of Elgin passed Ordinance 51.050 on December 15, 1997, and

WHEREAS, the ordinance contained an error in that part of the legal description of the

land to be annexed contained an error in the legal description based on erroneous information

supplied by the Wabasha County Courthouse, and

WHEREAS, the City of Elgin desires to amend the said ordinance to rectify the error.

# NOW THEREFORE, IT IS ORDAINED BY THE CITY OF ELGIN, MINNESOTA

### AS FOLLOWS:

- 1. The legal description of the land to be annexed is hereby amended to that description contained on Exhibit A hereto, which is made a part hereof as though fully set forth herein.
- 2. This ordinance shall take effect upon the latest of date of passage, approval by the State Municipal Board, and publication according to law.


Legal Description of Property to be annexed:
