## ORDINANCE NO. 404 $2^{ND}$ SERIES

# AN ORDINANCE ANNEXING PROPERTY ALONG COUNTY STATE AID HIGHWAY 44 TO THE CORPORATE LIMITS OF ATHE CITY OF ALEXANDRIA

WHEREAS, the property owners located within the area described below petitioned the Alexandria City Council to annex this territory to the City of Alexandria, pursuant to <u>Minnesota Statutes</u>, Section 414.033, Subdivision 5,

WHEREAS, the petitioners are the sole property owners within the territory, and

WHEREAS, the territory currently abuts upon the northwesterly boundaries of the City Limits and none of the territory is presently a part of any incorporated city, and

WHEREAS, the territory is unplatted land containing 47.44 acres in 2 parcels owned by 2 property owners, and

WHEREAS, the territory is vacant land which is deemed to be or about to become suburban in character in usage, thereby requiring municipal water services, and

WHEREAS, no public hearing is required because the petitioners represent all of the property owners of the territory proposed for annexation.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ALEXANDRIA HEREBY ORDAINS:

SECTION I. That the Corporate Limits of the City of Alexandria are hereby extended to include land as described and the same is hereby annexed and included within the City.

SECTION II. That the territory to be annexed is described as:

(KARNIS ANNEXATION)

All that part of the East half of the Southeast Quarter (E ½ SE ¼) of Section 12, Township 128 North, Range 38 West, Douglas County, Minnesota, lying easterly and southeasterly of C.S.A.H. No. 44, <u>except</u> the following described tracts:

- 1. RIDGEWOOD SOUTH, according to the recorded plat thereof.
- That part of the Northeast Quarter of the Southeast Quarter (NE ¼ SE ¼) of Section 12, Township 128 North, Range 38 West, and that part of the Northwest Quarter of the Southwest Quarter (NW ¼ SW ¼) of Section 7, Township 128 North, Range 37. West, Douglas County, Minnesota, described as follows:

Commencing at the southeasterly most corner of Lot 7, Block One, "RIDGEWOOD SOUTH", according to the recorded plat thereof;

thence South 84 degrees 59 minutes 39 seconds West, record bearing, along the southerly most line of said Lot, 311.37 feet to a point on a 75.00 foot radius curve which center of circle bears North 81 degrees 37 minutes 54 seconds West from said point, said curve being the easterly most line of Karnis Drive;

thence southwesterly, along said curve and along said easterly line, central angle 64 degrees 56 minutes 07 seconds, 85.00 feet to the point of beginning of the land to be described;

thence South 18 degrees 40 minutes 42 seconds West 44.26 feet;

thence South 60 degrees 47 minutes 57 seconds West 65.73 feet to a line bearing South 49 degrees 55 minutes 14 seconds East from the point beginning;

thence North 49 degrees 55 minutes 14 seconds West 324.00 feet to the point beginning, containing 0.40 acres more or less.

Beginning at the northwesterly most corner of Lot 1, Block Two, "RIDGEWOOD SOUTH", according to the recorded plat thereof;

thence South 07 degrees 13 minutes 43 seconds East, record bearing, along the westerly line of said Block Two and its southerly extension thereof, 446.00 feet to the northwesterly most corner of Lot 1, Block Three, said "RIDGEWOOD SOUTH";

thence South 34 degrees 32 minutes 26 seconds East, along the southwesterly most line of said Block Three, a distance of 298.00 feet to the southwesterly most corner of Lot 2 of said Block Three;

thence South 62 degrees 00 minutes 00 seconds West 465.92 feet;

thence South 89 degrees 33 minutes 52 seconds West, 406.84 feet to the east line of County State Aid Highway No. 44;

thence North 00 degrees 26 minutes 08 seconds West, along said east line, 354.33 feet;

thence northeasterly, along the southeasterly most line of said Highway and along a tangential curve, concave to the southeast, radius 539.91 feet, central angle 83 degrees 12 minutes 26 seconds, 784.08 feet;

thence North 82 degrees 46 minutes 17 seconds East, along the southerly most line of said Highway and along tongent, 124.85 feet to the point of beginning.

The tract contains 12.00 acres more or less.

SECTION III. That the territory is declared to be zoned R-1 Single Family Residential and the Alexandria Zoning District Map is amended to reflect this designation.

SECTION IV. The City Clerk is directed to file copies of this ordinance with the Minnesota Municipal Board, the Douglas County Auditor and the La Grande Township Board of Supervisors.

SECTION V. This ordinance shall be in full force and effect from and after its passage, publication, and approval by the Minnesota Municipal Board.
