ORINANCE NO. 122, 2<sup>nd</sup> SERIES

**AN ORDINANCE OF THE CITY OF CROOKSTON, MINNESOTA, EXTENDING  
THE CORPORATE LIMITS OF THE CITY TO INCLUDE CERTAIN  
UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE  
LIMITS OF THE CITY.**

**WHEREAS**, the territory described below is not presently within the corporate limits of any incorporated city; and

**WHEREAS**, this territory abuts upon the corporate limits of the City at the northerly boundary thereof and is deemed to be urban or suburban in character; and

**WHEREAS**, this territory is owned in fee by the City;

**BE IT ORDAINED BY THE CITY OF CROOKSTON, as follows:**

Section 1. **TERRITORY ANNEXED.**

The corporate limits of the City of Crookston, Minnesota are hereby extended to include the unplatted property described as follows now owned by the City:

---That part of Government Lot 4 and part of the Southeast Quarter of the Southwest Quarter of Section 18, Township 150 North, Range 46 West of the Fifth Principal Meridian, Polk County , Minnesota, described as follows:

Commencing at an iron pipe monument at the southwest corner of said Section 18; thence East, assumed bearing, along the monumented south line of said Section 18 a distance of 938.65 feet to the point of beginning of the tract to be described; thence North 520.00 feet to an iron pipe monument; thence East, parallel with the south line of said Section 18 a distance of 349.00 feet to an iron pipe monument; thence South 520.00 feet to the south line of said Section 18; thence West along the south line of said Section 18 a distance of 349.00 feet to the point of beginning, containing 4.17 acres more or less.

**Section 2. FILING.**

The City Clerk is directed to file certified copies of this Ordinance with Minnesota Municipal Board, the Town Clerk of the effected township, the County Auditor of the county in which the property is located and the Minnesota Secretary of State. The Clerk is directed to immediately deliver a copy of this Ordinance to the appropriate County Auditor.

**Section 3. EFFECTIVE DATE OF ANNEXATION.**

This Ordinance shall take effect upon its passage and publication according to the provisions of the Home Rule Charter for the City of Crookston, Minnesota, and upon approval by the Minnesota Municipal Board.
