

CENTER CITY RESOLUTION NO. 98-03-2; ANNEXATION OF LANDS

AT a public hearing of the Center City Council, held the 10th day of March, 1998, Councilperson Mark Wolcott introduced and moved for the adoption of the following resolution:

WHEREAS; on January 14, 1998, the City did receive a Petition to annex the following described lands to the City,

1. The SW 1/4 of the SW 1/4 of Sec. 26, Twp. 34, Range 20, except the East 200 feet thereof.
2. That part of the NW 1/4 of the NW 1/4 (Govt. Lot 3) of Sec. 35, Twp. 34, Range 20, lying westerly of the following described line: Commencing at the mid-point of the North line of Govt. Lot 3; thence west, along said North line, 162 feet, being the point of beginning of said line: thence South 800 feet, more or less, to the shoreline of Chisago Lake, and there terminating.
(now called South Center Lake)

WHEREAS; The City did set the time, date and place for a public hearing on said Petition, pursuant to M.S. 414.033 (2b), and

WHEREAS; due notice of said hearing was given to those persons and entities required by the cited statute, and

WHEREAS; said hearing was held on the 10th day of March, 1998, at which the Council heard all interested persons on the proposed Petition, and

WHEREAS; the Council determined that the Petition was proper, the required procedures compiled with, and that it was in the best interests of the City to annex said lands:

NOW, THEREFORE, BE IT RESOLVED: That the described lands be annexed to the City, that the Mayor and Clerk execute any and all ordinances and documents necessary or incidental to complete said annexation, and the Clerk be authorized and directed to publish and distribute said ordinance, according to law.

Councilperson Mike Hilber seconded said motion, whereupon same was put to a vote:

WHEREUPON; said motion was duly passed.

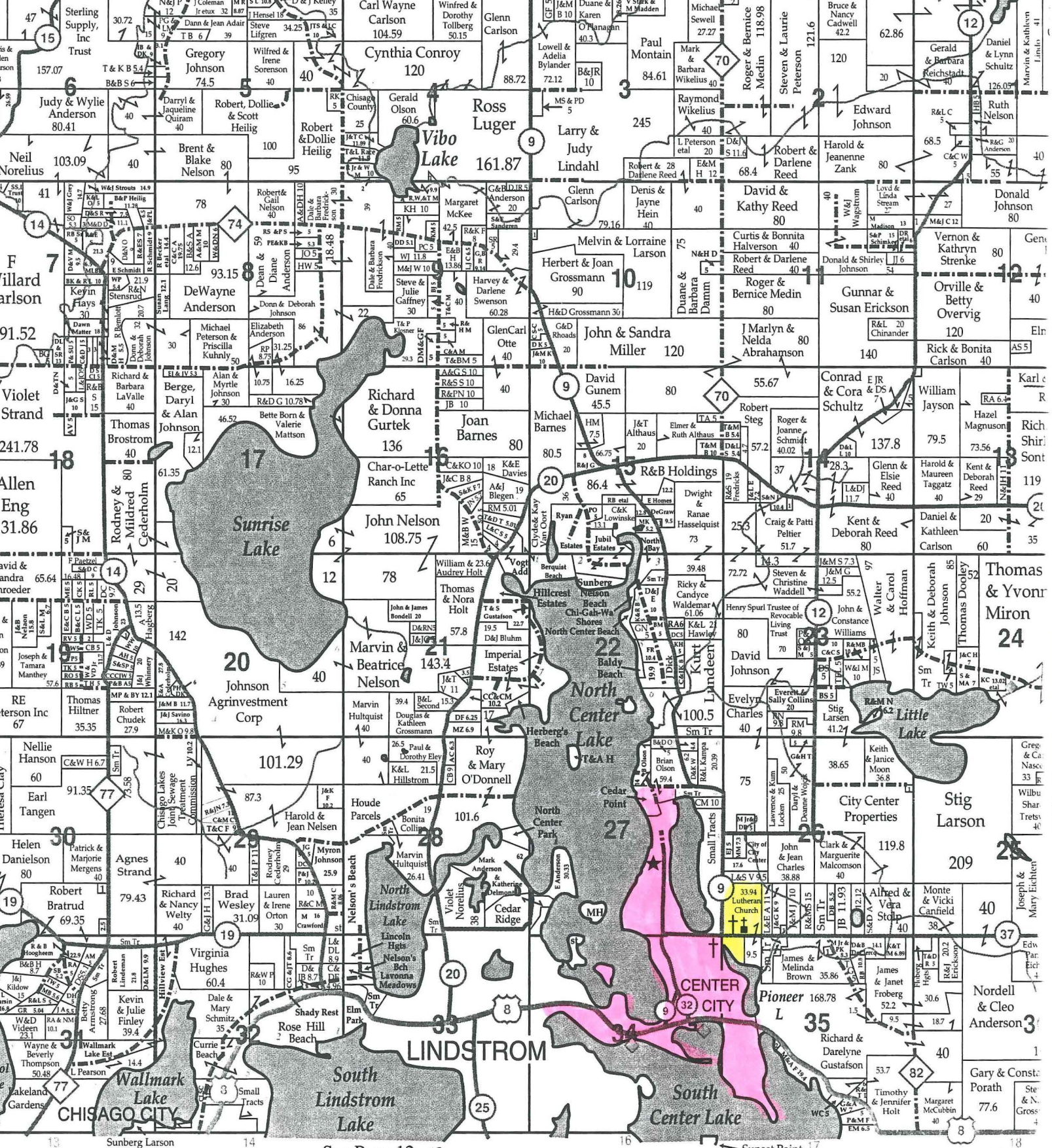
