## ORDINANCE NUMBER 179

### AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF PEQUOT LAKES TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY

WHEREAS, the property described below is not presently within the corporate limits of any incorporated city: and

WHEREAS, this property abuts upon the corporate limits of the City of Pequot Lakes boundary thereof and is deemed to be urban or suburban in character: and

WHEREAS, this property is owned in fee by the city:

**The City Council of Pequot Lakes does hereby ordain:**

**Section 1. Territory annexed.** The corporate limits of the City of Pequot Lakes are hereby extended to include the unplatted properties described as follows now owned by the City:

Beginning 48 rods North of the Southwest corner of the W 1/2 SW 1/4 of Section 11, Township 136, Range 29, thence East 80 rods, thence North 20 rods, thence West 80 rods, thence South 20 rods to the place of beginning, excepting therefrom the North 100 feet.

EXCEPT:

that part of the SW 1/4 SW 1/4, Section 11, Township 136, Range 29, described as follows: Commencing at a point on the West line of said Section 11 (said west line is assumed to bear north-south) 48 rods north of the southwest corner thereof; thence east along the south line of Mezzenga tract 241.11 feet to the actual point of beginning of tract to be herein described; thence north 100.00 feet, thence east 100.00 feet; thence south 100.00 feet to its intersection with the south line of Mezzenga tract; thence west along said south line 100.00 feet, more or less, to the point of beginning, Crow Wing County, Minnesota.

**Section 2. Filing.** The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

**Section 3. Effective date of annexation.** This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.

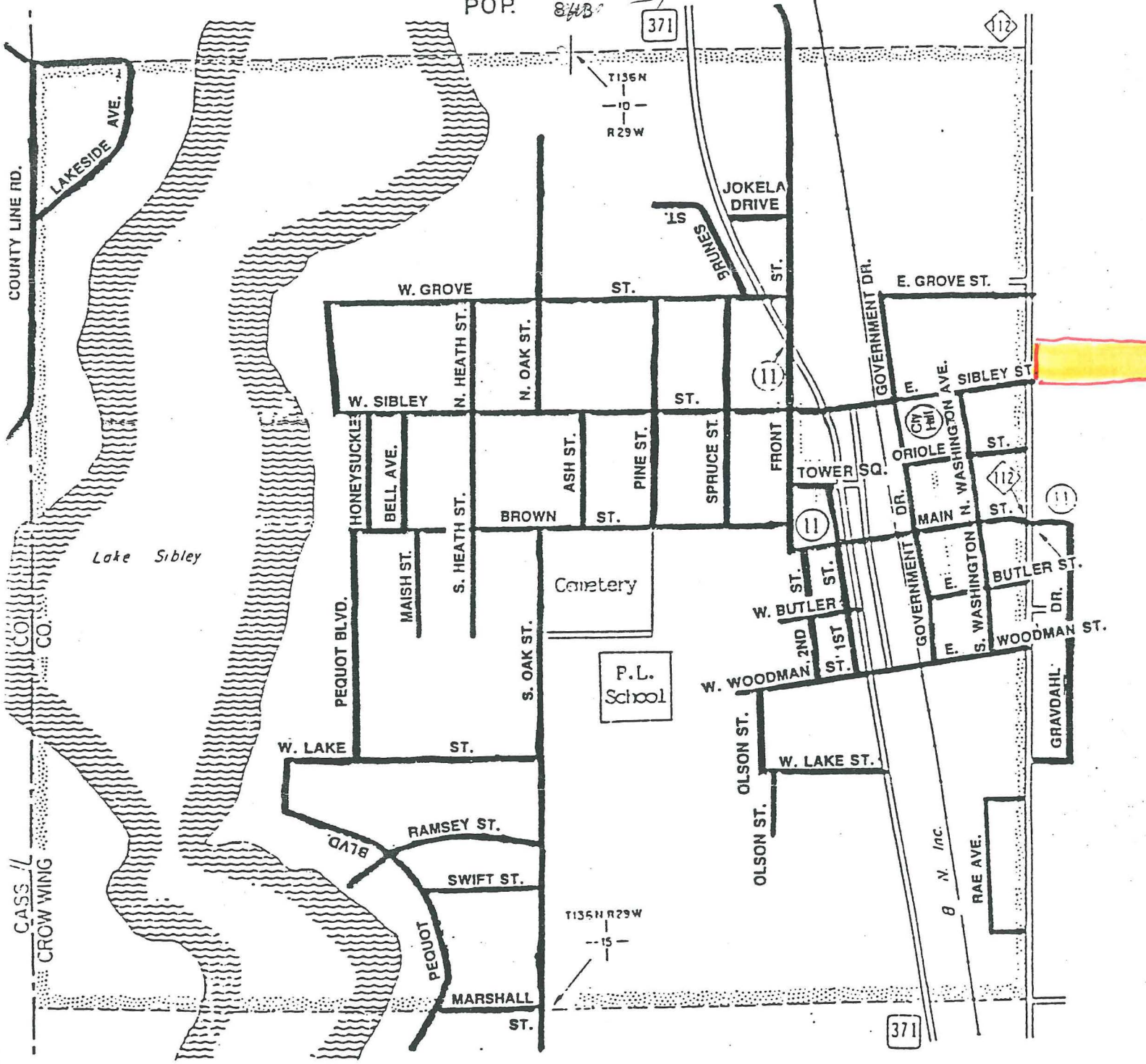
