

Amended Ordinance No. 101

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF NEW YORK MILLS TO INCLUDE
CERTAIN UNINCORPORATED CITY-OWNED LAND
ABUTTING UPON THE CITY LIMITS

WHEREAS, the land embraced within the area hereinafter described consists of 80 acres of unplatted land, no part of which is included within the city limits of an incorporated city; and

WHEREAS, the land hereinafter described abuts upon the city limits and is deemed to be urban or suburban in character because it is owned by the City;

NOW THEREFORE, The City Council resolves as follows:

1. Territory Annexed The corporate limits of the City of New York Mills are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

The South Half of the Northwest Quarter (S ½ of NW ¼) of Section 9, Township 135, Range 37, subject to public highway rights of way and subject to easement over the west one rod thereof; and subject to mineral reservations of record, if any.

2. Filing The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota municipal board, Newton Township board, the Otter Tail County Auditor, and the Minnesota Secretary of State.

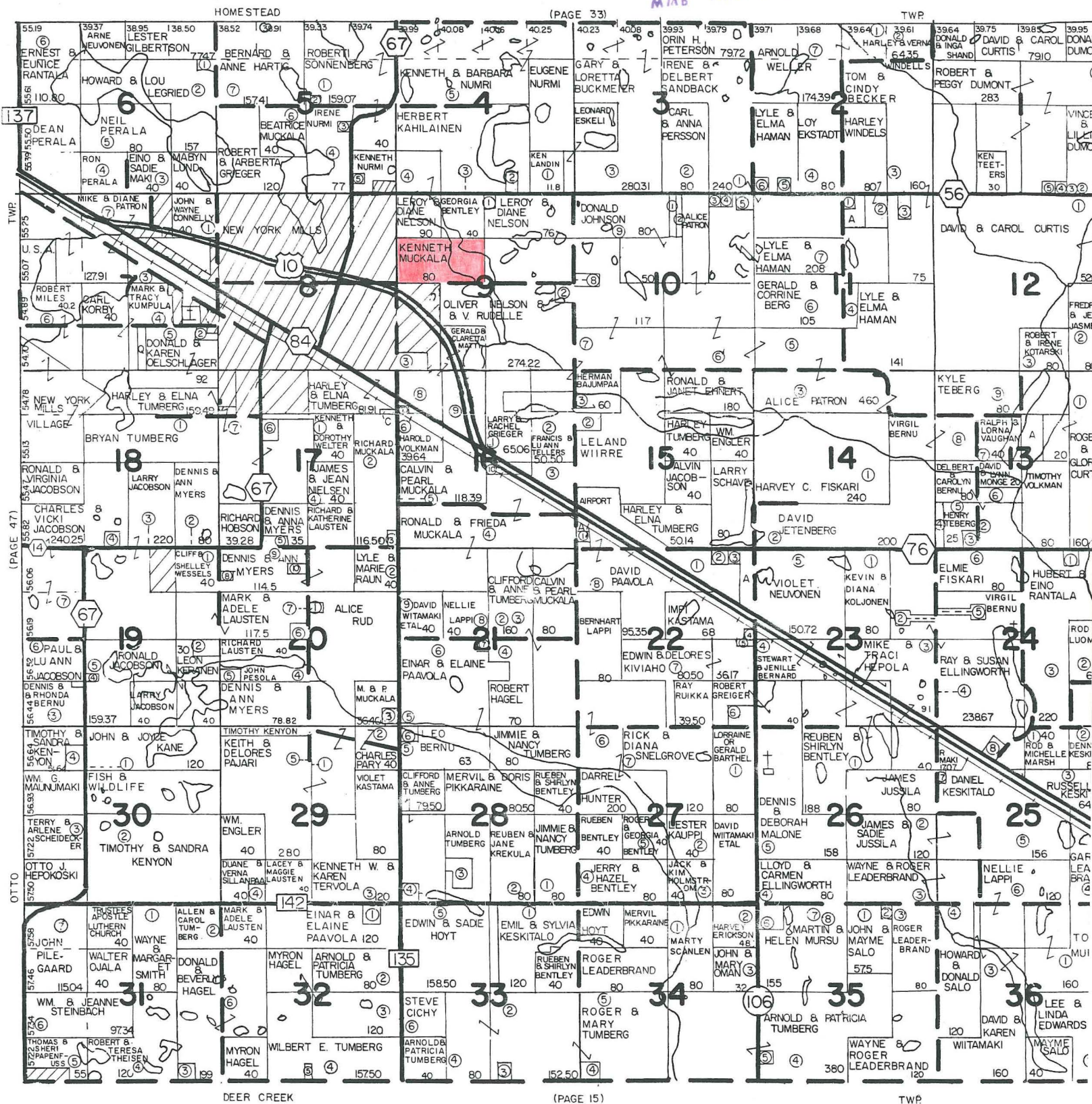
3. Effective Date This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in the immediately foregoing paragraph.
