**PETITION FOR ANNEXATION**

**TO THE CITY COUNCIL OF THE CITY OF BAGLEY, MINNESOTA:**

The owners of the real estate described on the attached Schedule A hereby request the City Council to annex this territory to the City of Bagley and to extend the city boundaries to include the same, and for that purpose respectfully state:

1. That the territory to be annexed consists entirely of platted lands lying entirely within the County of Clearwater Minnesota and the description of such lands is as follows:

**Lot One (1) less the southeasterly 60 feet thereof, and Lots Two (2), Three (3), Four (4), Five (5) Six (6) and Lot Seven (7), Block Four (4) Berg's Subdivision and Lots Four (4), Five (5), Six (6) and Seven (7) Block Five (5) Berg's Subdivision.**


2. The territory described above abuts upon the city limits and none of it is presently included within the corporate limits of any incorporated city, village or borough.
