CITY OF RANIER ORDINANCE NO. 116

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF RANIER TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND, NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated March 16, 1998, requesting annexation of the territory hereinafter described was duly presented to the council on the 13th day of April, 1998 and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, or the government body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the eastern boundary thereof;

The council of the City of Ranier, Minnesota, ordains:

Section 1. The city council hereby determines

- (1) that the territory described herein abuts upon the city limits and is urban or suburban in character; and
- (2) that none of the territory is now included within the limits of any city.

Section 2. The population of the territory is 0.

Section 3. Territory annexed. The corporate limits of the city are hereby extended to include the planted land located in Koochiching County, Minnesota, described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Lot 30, Plat of Brennens Beach

P. O. Box 186 Ranier, MN 56668

Section 4, Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 5. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.
