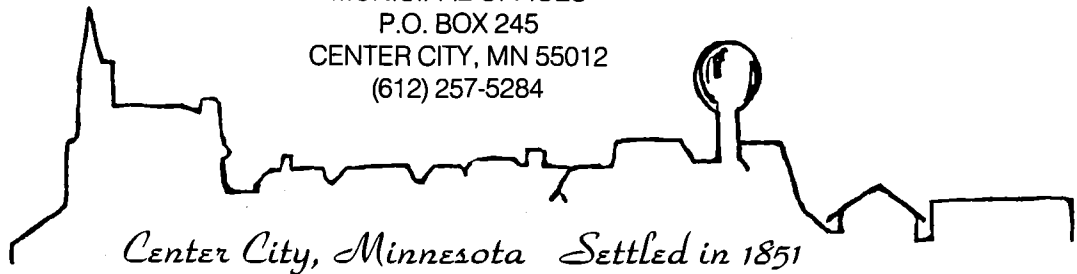

CENTER CITY ORDINANCE NO. 98-10-08

In accordance with Center City Resolution No. 98-10-08, the following described lands are hereby annexed to the City of Center City:

1) Legal Description - Lloyd and Sharon Vetter (farm):

That part of the Northwest Quarter of the Southwest Quarter of Section 26, Township 34 North, Range 20 West, Chisago County, Minnesota, lying south of the north 1000 feet thereof, except the east 16 feet thereof. Also except all that part of the following described property, which lies westerly of Chisago County Road No. 9 as now laid out and traveled (also known as Oasis Road):

That part of the Northwest Quarter of the Southwest Quarter of said Section 26, described as follows:

Commencing at a point on the west line of said Section 26, a distance of 1361.03 feet north of the section post at the southwest corner of said Section 26, which is the point of beginning of the land here described; thence running North, a distance of 146.67 feet; thence running East, at right angles to the east line of said Northwest Quarter of the Southwest Quarter; thence South, along said east line, 146.67 feet to a point directly west of the point of commencement; thence running West, at right angles to the point of commencement, and there terminating.

Subject to existing highway, easement and rights of way of record.

Subject to and together with any other valid easements, restrictions and reservations.

2) Legal Description - Chisago County (Highway Department Facility):

The South 320 feet of the North 1000 feet of the Northwest Quarter of the Southwest Quarter (NW 1/4 of SW 1/4) of Section Twenty-six (26), Township Thirty-four (34) North, Range Twenty (20) West, except the East 16 feet thereof. Subject to Oasis Road (also known as County State Aid Highway 9).

And

That the part of the South 647 feet of the North 680 feet of the Northwest Quarter of the Southwest Quarter (NW 1/4 of SW 1/4) of Section Twenty-six (26), Township Thirty-four

(34) North, Range Twenty (20) West, lying East of the West 826 feet thereof, except the East 16 feet thereof.


Subject to Park Trail (also known as County State Aid highway 12).

And

The East 489 feet of the West 826 feet of the South 80 feet of the North 680 feet of the Northwest Quarter of the Southwest Quarter (NW 1/4 of SW 1/4) of Section Twenty-six (26), Township Thirty-four (34) North, Range Twenty (20) West.
