TO: THE TOWN BOARD OF REDWOOD FALLS TOWNSHIP, P.O. BOX <u>6</u><sup>γ</sup>, REDWOOD COUNTY, REDWOOD FALLS, MINNESOTA 56283, AND THE STATE OF MINNESOTA MUNICIPAL BOARD, SUITE 225 BANDANA SQUARE, 1021 BANDANA BOULEVARD EAST, ST. PAUL, MINNESOTA 55108.

WHEREAS, the city council of Redwood Falls intends to annex certain territory within the town of Redwood Falls, described as follows:

All that part of the North Half (N1/2) of the Redwood River located in the Southwest Quarter of the Southwest Quarter (SW4SW4) of Section One (1), Township One Hundred Twelve (112), Range Thirty-six (36), and the Southeast Quarter of the Southeast Quarter (SE4SE4) of Section Two (2), Township One Hundred Twelve (112), Range Thirty-six (36), and that part of the Redwood River located in the Southwest Quarter of the Southeast Quarter (SW4SE4) of Section Two (2), Township One Hundred Twelve (112), Range Thirty-six (36), described as follows: commencing at a point where the North shoreline of the Redwood River intersects with the East line of said Southwest Quarter of the Southeast Quarter (SW4SE4) of said Section Two (2); thence South along the East line of said quarter to the centerline of the Redwood River; thence West along the centerline of the Redwood River for a distance of 445 feet; thence South to the South shoreline of the Redwood River; thence West along the south shoreline of the Redwood River to the intersection of the west line of the Peavey Lakeview Addition as extended to the south shore of the Redwood River; thence north to where the north shoreline of the Redwood River intersects with the west line of the Peavey Lakeview Addition; thence east along the north shoreline of the Redwood River to the point of beginning; and

WHEREAS, the above-described land is 40 acres or less in area and 60 percent or more of its perimeter is bordered by land within the City of Redwood Falls; and

WHEREAS, there are no people residing on the above described land;
