## CITY OF RANIER ORDINANCE NO. 117

## AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF RANIER TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND, NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated September 27, 1998, requesting annexation of the territory hereinafter described was duly presented to the council on the 28<sup>th</sup> day of September, 1998 and

WHEREAS, the petition was signed by all owners: and

WHEREAS, no objections to the annexation have been received from the town board, or the government body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the southern boundary thereof;

The council of the City of Ranier, Minnesota, ordains:

Section 1. The city council hereby determines

- (1) that the territory described herein abuts upon the city limits and is urban or suburban in character; and
- (2) that none of the territory is now included within the limits of any city.

Section 2. The population of the territory is 0.

Section 3. Territory annexed. The corporate limits of the city are hereby extended to include the platted land located in Koochiching County, Minnesota, described as follows and the same is hereby annexed to and included with in city as effectually as if it had originally been a part thereof:

That part of Government Lot Five (5), of Section Thirty (30), Township Seventy One (71), Range Twenty Three (23), described as follows:

Beginning at a point Twenty (20) Feet South of the Southwest corner of Block thirty-three (33), Plat of Ranier; thence East parallel with and Twenty (20) Feet South of the South line of Blocks thirty-three and thirty-two (33 and 32), a distance of Six Hundred (600) Feet; more or less; thence deflect right eighty-nine (89) degrees forty-two (42) minutes and run south to the north right of way line of State Highway No. 11; thence deflect right and run Westerly and Northwesterly along said Right of Way line to the West line of above said Block thirty-three (33) produced south: thence North to the point of beginning.


Section 4. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.


