ORDINANCE NO. 416, SECOND SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY OF MARSHALL, MINNESOTA

WHEREAS, The territory described below is not presently within the corporate limits of any incorporated city; and

WHEREAS, The territory abuts upon the corporate limits of the city at the boundaries and is deemed to be urban in character; and

WHEREAS, This territory is owned in fee by the City of Marshall.

The common Council does ordain as follows:

<u>Section 1.</u> Territory Annexed. The corporate limits of the City of Marshall, Minnesota is hereby extended to include the unplatted property described as follows now owned by the City of Marshall, Minnesota to wit:

Legal description shown on Exhibits 1 through 23 which are attached and made a part of this ordinance.

<u>Section 2.</u> Filing. The City Finance Director/City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the Town Clerk of the affected township, and the Minnesota Municipal Board.

<u>Section 3.</u> Summary approved. The council hereby determines that the text of the summary of this ordinance prepared by the Marshall City Finance Director/City Clerk, marked "Official Summary of Ordinance No. 416" and a copy of which is attached hereto, clearly informs the public of the intent and effect of the ordinance. The council further determines that publication of the title and such summary will clearly inform the public of the intent and effect of the ordinance.

<u>Section 4.</u> Posting and filing. The clerk shall see that a copy of this ordinance is filed in his office and in the Marshall Lyon County Library, and the First Floor of Marshall City Hall, which the council hereby designates as locations at which a copy is available for inspection by any person during regular office hours.

<u>Section 5.</u> Publication. The clerk shall publish the title of this ordinance and the official summary in the official newspaper with notice that a printed copy of the ordinance is available for inspection by any person during regular office hours at the office of the Marshall City Finance Director/City Clerk and every other location specified in Section 4.

<u>Section 6.</u> Effective date. This ordinance takes effect upon its passage and the publication of its title and the official summary.
