ORDINANCE NO. 1400.02

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF RICHMOND TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated August 40, 1999, requesting annexation of the territory hereinafter described was duly presented to the council on the 2544 day of August, 1999; and

WHEREAS, the petition was signed by the fee owner and contract for deed vendee of said territory, consisting of all the property owners; and

WHEREAS, the land described in the Petition abuts upon the City limits at the westerly boundary thereof;

The Council of the City of Richmond, Minnesota, ordains:

- The City Council hereby determines (1) that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and (2) that none of the territory is now included within the limits of any City.
- Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

See Exhibit A attached hereto and made a part hereof by reference

- Section 3. Zoning Classification. The area annexed as described in Section 2 of this ordinance is hereby classified as residential as defined in the City of Richmond Zoning Ordinance No. 500 25 and the Zoning Administrator is hereby directed to amend the official Zoning Map to display the annexed area and the zoning classification.
- Section 4. Filing. The City Clerk/Treasurer is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, and Town Clerk for Munson Township, and the Stearns County Auditor.
- Section 5. Effective Date. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 4, and approval of the ordinance by the Minnesota Municipal Board.
