ORDINANCE NUMBER 184

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF PEQUOT LAKES TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY

WHEREAS, the property described below is not presently within the corporate limits of any incorporated city; and

WHEREAS, this property abuts the corporate limits of the City of Pequot Lakes boundary thereof and is deemed to be urban or suburban in character; and

WHEREAS, the property owners have filed a petition for annexation, and

WHEREAS, the property to be annexed constitutes 50 acres, and is not presently served by the public sewer facilities or public sewer facilities are not otherwise available, and

WHEREAS, the property is in the service area of Minnesota Power & Light Co. and the property owners have waived their right to receive notice pursuant to M.S. 414.033, Subd. 13, regarding an estimate of the cost impact of any change in electric utility services, including rate changes and assessments, resulting from the annexation.

The City Council of Pequot Lakes does hereby ordain:

Section 1. Territory Annexed. The corporate limits of the City of Pequot Lakes are hereby extended to include the platted property now owned by Unlimited Potential Ent., LLC, Shores Financial Corporation and Brunes Royce and described as follows:

The part of the Northeast Quarter of the Southeast Quarter of Section 15, Township 136 North, Range 29 West, Crow Wing County, Minnesota, Lying Westerly of the Westerly right of way line of State Highway Number 371 and lying Southerly of the line described as follows.

Beginning at the Northwest corner of the South half of the Northeast Quarter of the Southeast Quarter of said Section 15; thence East along the North line thereof to its intersection with the Westerly line of that certain tract described in the recorded deed filed in Book 303 of Deeds, Page 1, extended Southeasterly; thence Northwesterly along said extended line to the Southwest corner of said tract; thence Northeasterly along the South line of said tract to the Westerly right of way line of State Highway number 371 and there terminating. Subject to that part thereof monumented in the plat of PEQUOT SHADY SHORES:

AND

That part of the Southeast Quarter of Southeast Quarter of Section 15, Township 136 North, Range 29 West, Crow Wing County, Minnesota Lying Westerly of the Westerly right of way line of State Highway Number 371. Subject to that part thereof monumented in the plat of PEQUOT SHADY SHORES.

AND

That part of the Northeast Quarter of the Northeast Quarter of Section 22, Township 136 North, Range 29 West, Crow Wing County, Minnesota lying North of the South 330 Feet thereof and lying Westerly of the Westerly right of way line of State Highway Number 371.

Except that part thereof described in deed recorded in the office of the County Recorder in book 234 of Deeds, Page 363

Subject to that part thereof monumented in the plat of PEQUOT SHADY SHORES.

Subject to easements, restrictions and reservations of record. Also subject to mineral reservations of record, if any.

Section 2. Filing. The City Clerk is directed to file certified copies of this Ordinance with the Secretary of State, The County Auditor of the County in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

Section 3. Effective date of Annexation. This Ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.




