ORDINANCE NO. 221, THIRD SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LUVERNE TO INCLUDE CERTAIN LANDS OWNED BY GLENN R. BURMEISTER, WALTER DEUTSCH AND BETTY DEUTSCH AND ABUTTING THE CITY OF LUVERNE (8.3 Acres So. of I-90 Drive-In Theatre Area)

WHEREAS, Glenn R. Burmeister, Walter Deutsch and Betty Deutsch have filed a Petition dated September 20, 1999, requesting the annexation to the City of Luverne of that certain real estate located in the County of rock, State of Minnesota, described as follows:

Commencing at the southwest corner of Section Fourteen (Sec. 14), Township One Hundred-two North (T102N), Range Forty-five West (R45W) of the Fifth Principal Meridian (5th P.M.), Rock County, Minnesota; thence due North on the west line of said Sec. 14, three hundred nineteen feet (319.0') to the point of beginning; thence North 87051' East, two hundred eighteen and eight/tenths feet (218.8'); thence North 62046' East, four hundred thirty and six/tenths feet (430.6'); thence North 0003' West, three hundred seventy-one and three/tenths feet (371.3'); thence North 89008' West, six hundred one feet (601.0') to the west line of said Sec. 14; thence due South, five hundred eighty-five and seven/tenths feet (585.7') to the point of beginning.

The above described tract contains seven and seven/hundredths acres (7.07 A.) The bearing of the west line of said Sec. 14 is assumed to be due North.

WHEREAS, Glenn R. Burmeister, Walter Deutsch and Betty Deutsch represent that they are the sole owners of the property, that the population of the area is zero, and that the property is unincorporated, abuts on the southerly boundary of the City of Luverne, is not included with any other municipality, is not included in any boundary adjustment proceedings pending before Minnesota Planning Municipal Boundary Adjustments, has a property area of less than 200 unplatted acres, is not presently served by public sewer facilities or public sewer facilities are not otherwise available, and is or about to become urban or suburban in character; and

WHEREAS, said property is currently served by the municipality's electric utility service, and the property owners have their right to receive notice pursuant to M.S. 4145.033, Subd. 13, regarding an estimate of the cost impact of any change in electric utility services, including rate changes and assessments, resulting from the annexation.

NOW THEREFORE, the City Council of the City of Luverne, Minnesota, does hereby ordain:

SECTION 1. That the City Council hereby determines and finds that the property described herein abuts the municipality, that the property is unplatted and less than 200 acres, that the area to be annexed is not presently served by public sewer facilities or public sewer facilities are not otherwise available, that the municipality has received a properly prepared Petition for Annexation from all of the owners of the property, that the area is appropriate for annexation by ordinance under M.S. 414.033, Subd. 5, and that the Petition complies with all the provisions of Minnesota Statutes 414.933.

SEC. 2. That the property is urban or suburban in nature or about to become so.


SEC. 3. That the property is currently served by the municipality's electric utility service and the property owners have waived their right to receive notice pursuant to M.S. 414.033, Subd. 13, regarding an estimate of the cost impact of any change in electric utility services, including rate changes and assessments, resulting from the annexation.

SEC. 4. That the corporate limits of the City of Luverne are hereby extended to include the property, and the same is hereby annexed to and included within the City of Luverne as if the property had originally been a part thereof.

SEC. 5. That the City Clerk is directed to file certified copies of this ordinance with Minnesota Planning Municipal Boundary Adjustments, Luverne Township, the Rock County Auditor-Treasurer, and the Minnesota Secretary of State.




