**ORDINANCE 42**

**AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF DENT, COUNTY OF OTTER TAIL  
TO INCLUDE CERTAIN UNINCORPORATED  
PROPERTY LYING WITHIN THE LIMITS OF THE CITY**

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village or borough; and

WHEREAS, the territory to be annexed is less than 40 acres; and

WHEREAS, this territory is completely surrounded by the City of Dent;

THE CITY COUNCIL OF DENT, MINNESOTA DOES HEREBY ORDAIN:

**Section 1. Territory Annexed.** The corporate limits of the City of Dent, Minnesota are hereby extended to include the platted and unplatted property described as follows:

A tract of land described as follows: The East 6.75 rods of the East 30 rods of the West 50 rods of the North 18 rods of the Northwest Quarter of the Southwest Quarter (NW<sup>1</sup>/<sub>4</sub> of SW<sup>1</sup>/<sub>4</sub>) of Section Thirty-four (34), Township One Hundred Thirty-six (136), Range Forty (40).

**Section 2. Filing.** The Secretary is directed to file certified copies of this ordinance with the Board of the Township in which the property is located, the Secretary of State, the County Auditor of the County in which the property is located and the Minnesota Municipal Board, pursuant to Minn.Stat. §414.033, Subd. 2.

**Section 3. Effective Date of Annexation.** This ordinance is effective and final on the date of publication and filing, pursuant to Minn.Stat. §414.033, Subd. 2.

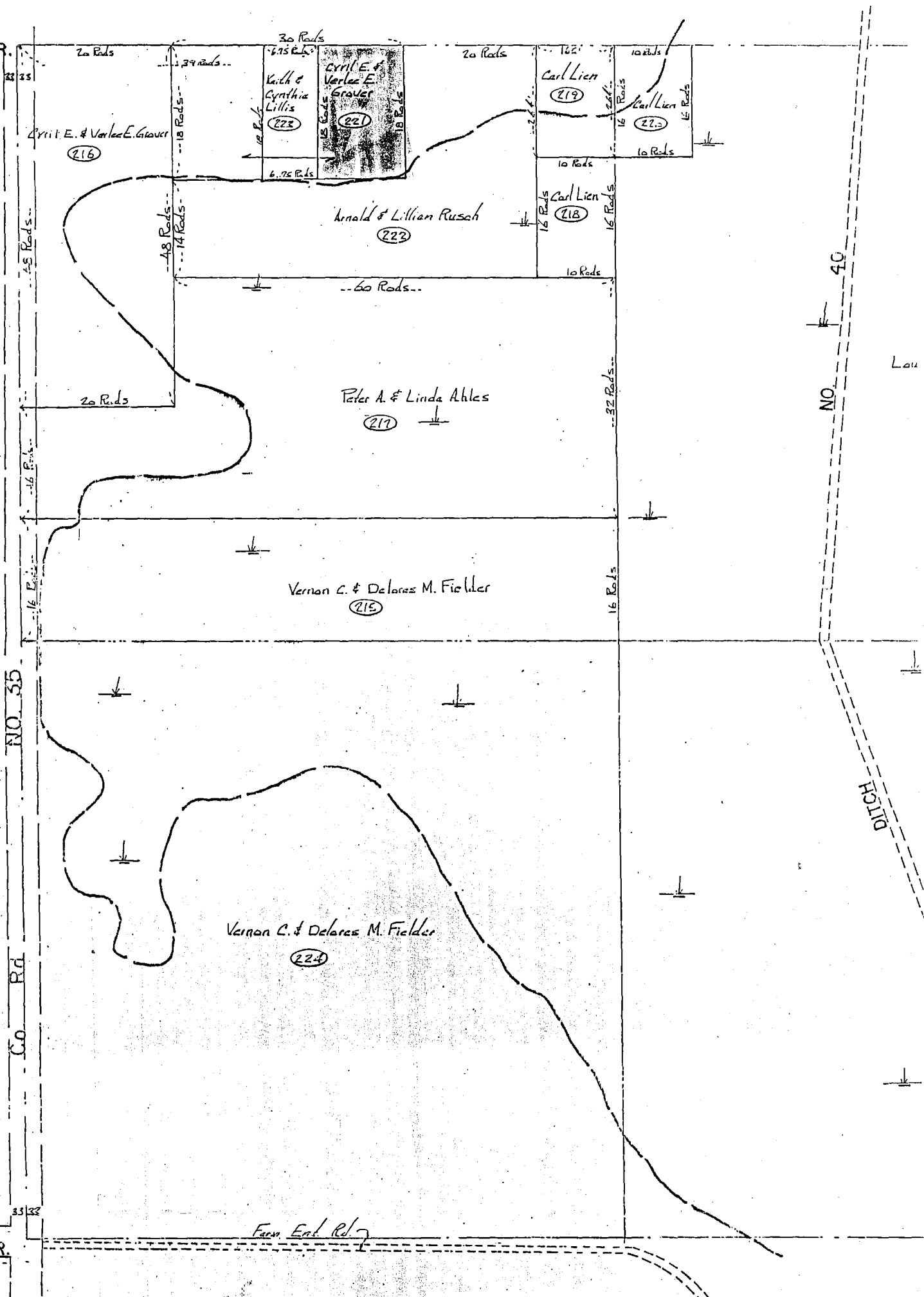
