AN ORDINANCE ANNEXING CERTAIN LAND INTO THE  
CORPORATE LIMITS OF THE CITY OF MAYER,  
CARVER COUNTY, MINNESOTA

THE CITY COUNCIL OF THE CITY OF MAYER, CARVER COUNTY, MINNESOTA,  
ORDAINS:

**Section 1. Statement of Character of Land.** The City of Mayer is the fee owner of certain land described below which presently abuts the corporate limits of the City, is not within the corporate limits of any incorporated city and is deemed to be urban or suburban in character.

**Section 2. Land Annexed.** Pursuant to Minnesota Statutes Section 414.033, Subd. 2, Clause 1, the corporate limits of the City of Mayer are hereby declared extended to encompass and include all that certain land situated in the County of Carver and legally described as follows:

All that part of the Northeast Quarter of Section 2, Township 116, Range 26, lying South and East of the Crow River described as follows:

Beginning at the Southeast corner of said Northeast Quarter; thence Northerly along the Easterly line thereof to the centerline of C. S. A. H. No. 30, said point being the actual point of beginning of the land to be described; thence continuing Northerly along said Easterly line 633.00 feet; thence Westerly parallel with the centerline of said C. S. A. H. No. 30, 1354.00 feet; thence Southwesterly to a point on the centerline of said C. S. A. H. No. 30 said point being 1550.00 feet Westerly of the point of beginning, as measured along the centerline of said C. S. A. H. No. 30; thence Easterly along said centerline to the point of beginning.


**Section 3. Filing.** The City Clerk-Treasurer is hereby directed to file certified copies of this Ordinance with the State of Minnesota Office of Strategic and Long Range Planning, the Town Clerk of the Town of Camden, the Carver County Auditor,

and the Minnesota Secretary of State and to publish this Ordinance in the Carver County News, all as required by law.

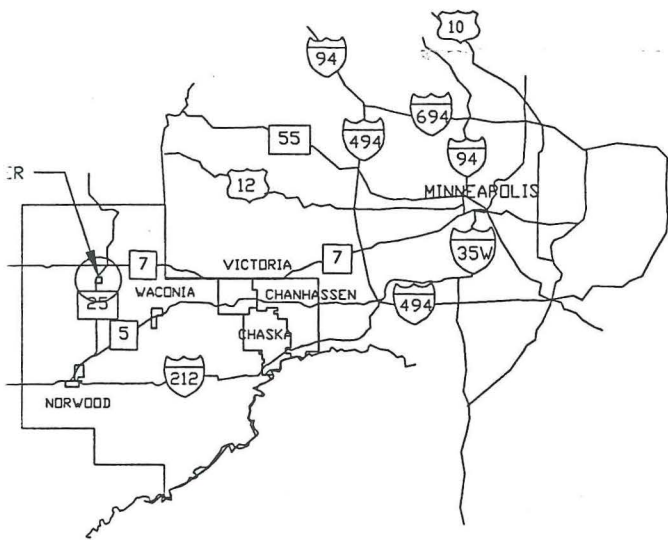

Adopted by the City Council of the City of Mayer this 10 day of January, 2000.

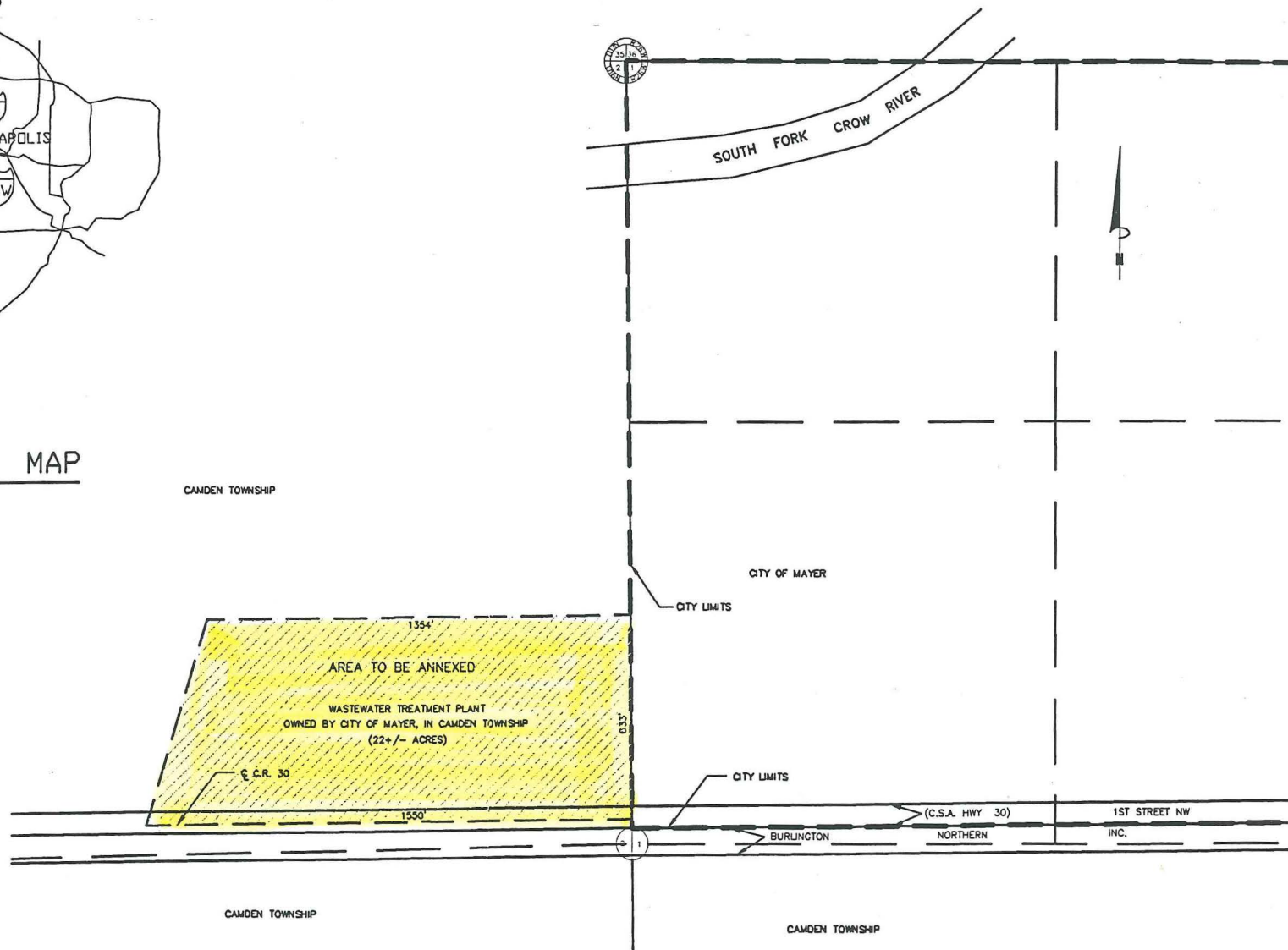

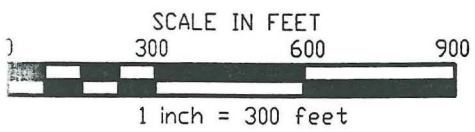

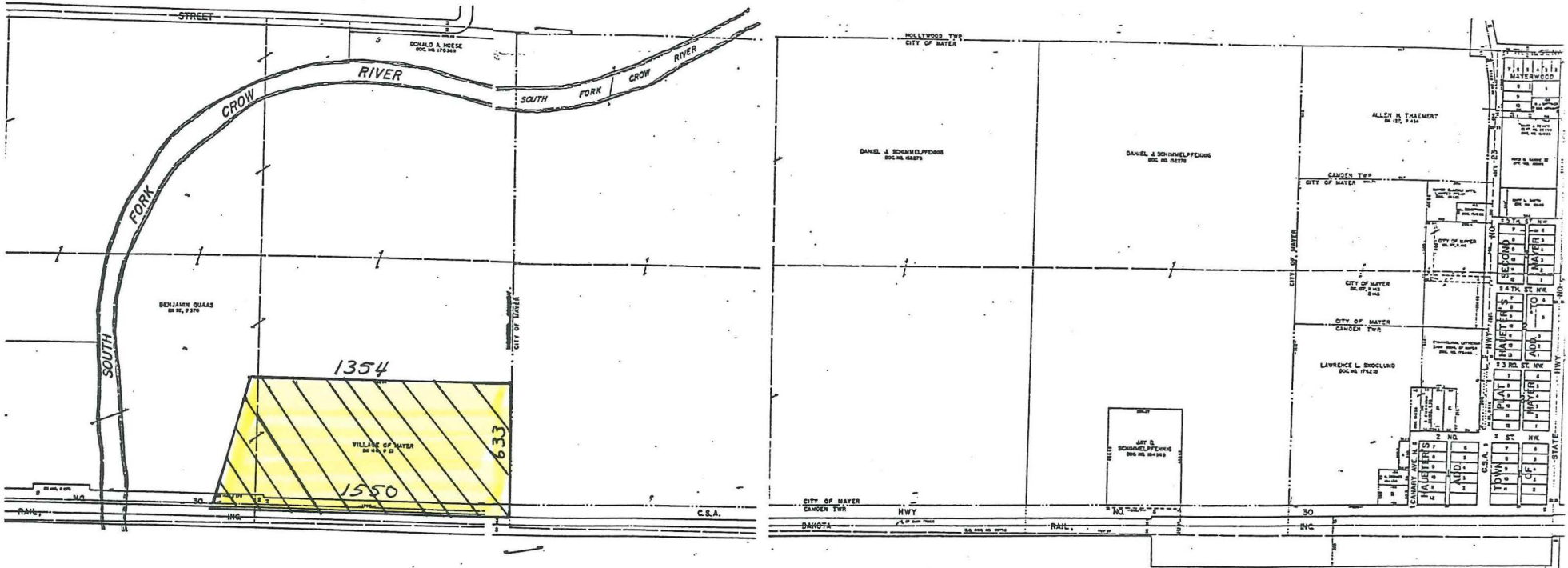
