

**TOWNSHIP WAIVER OF OBJECTION TO ANNEXATION PETITION**

IN THE MATTER OF THE PETITION OF THE OWNERS OF PROPERTY LOCATED IN SUMMERVILLE ESTATES FOR ANNEXATION OF UNINCORPORATED ADJOINING PROPERTY TO THE CITY OF ALEXANDRIA, MINNESOTA.

**TO THE CITY OF ALEXANDRIA AND THE STATE OF MINNESOTA**

The Board of Supervisors for the Township of Alexandria, Douglas County, Minnesota specifically acknowledges notice from the City of Alexandria of the Petition for Annexation signed by the property owners of property in Summerville Estates and received by the City of Alexandria on Monday, January 24, 2000.

The property consists of platted land in Alexandria Township, Douglas County containing approximately 58.46 acres in eighty-six (86) parcels owned by one-hundred-three (103) property owners and is described as:

Lots 1 through 3, Block One, "Summerville Estates"

and

Lots 1 and 2, Block Two, "Summerville Estates"

and

Lots 1 through 25, Block Three, "Summerville Estates"

and

Lots 1 through 14, Block Four, "Summerville Estates"

and

The west 273' of the south 158' of Government Lot 4 lying south of Lot 14, Block Four, "Summerville Estates"

and

Lot 1, Block Five, "Summerville Estates"

and

Lots 1 and 2, Block Six, "Summerville Estates"

and

Lots 1 through 4, Block Seven, "Summerville Estates"

and

Lots 1 through 3, Block Eight, "Summerville Estates"

and

Lots 1 and 2, Block Nine, "Summerville Estates"

and

Lot 1, Block Twelve, "Summerville Estates"

and

Outlot B, "Summerville Estates"

and

Lots 1 through 7, Block One, "1<sup>st</sup> Addition to Summerville Estates"

and

Lots 1 through 3, Block Two, "1<sup>st</sup> Addition to Summerville Estates"

and

Lots 1 through 4, Block One, "2<sup>nd</sup> Addition to Summerville Estates"

and

West 130' of Lot 1, Block Two, "2<sup>nd</sup> Addition to Summerville Estates"

and

East 130' of Lot 1, Block Two, "2<sup>nd</sup> Addition to Summerville Estates"

and

Lots 2 through 6, Block Two, "2<sup>nd</sup> Addition to Summerville Estates"

and

Lots 1 through 4, Block One "3<sup>rd</sup> Addition to Summerville Estates"

and

Lots 1 through 7, Block One, "4<sup>th</sup> Addition to Summerville Estates", also with the platted roads in said plats also known as Glenn Street, Armstrong Road, Shepard Road, McAuliffe Place, Steger Road, Aldrin Circle and Armstrong Circle.

Notice of this petition and its provisional acceptance by the City of Alexandria was provided to this Board by the City of Alexandria on February 2, 2000.

After due deliberation and consideration, the Township of Alexandria specifically waives objection to the above referenced petition, and consents to the annexation of the subject land to the City of Alexandria, without the need for a hearing or other proceedings to be held by the Minnesota Municipal Board as contemplated by Minnesota Statutes, Section 414.033, Subdivision 5.
