CENTER CITY RESOLUTION NO. 99-12-7; ANNEXATION OF LANDS

AT a regular meeting of the Center City Council, held the 7th day of December, 1999, Councilperson <u>Carmelita Nelson</u> introduced and moved for the adoption of the following resolution:
