CITY OF WACONIA **ORDINANCE NO. 513**

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS OF THE CITY OF WACONIA, MINNESOTA (PEITZ)

WHEREAS, The City of Waconia adopted Resolution No. 2000-62 on April 17, 2000, accepting a petition from Raymond Peitz, Rose Peitz, Richard Peitz, Thomas Peitz and Patricia Peitz, to annex certain lands into the corporate limits of the City of Waconia, Minnesota; and

WHEREAS, Posted, published and written notice has been provided to Waconia Township and all landowners within and contiguous to the area to be annexed; and

WHEREAS, No objections have been received regarding this Petition for Annexation; and

WHEREAS, Said annexation of said lands is consistent with the City of Waconia's Comprehensive Plan.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WACONIA, CARVER COUNTY, MINNESOTA, DOES HEREBY ORDAIN:

SECTION 1. Declaration. It is hereby determined that the annexation of lands described in Section 2 below would be in the best interest of the City of Waconia.

SECTION 2. <u>Territory Annexed.</u> The corporate limits of the City of Waconia are hereby extended to encompass and embrace all of the territory described as follows and said land is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

SECTION 3. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Planning Board of the State of Minnesota, the Secretary of State, and the County Auditor of Carver County as required by law.

SECTION 4. Effective Date of Annexation. This Ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 3 and shall be deemed final upon approval of this Ordinance by the Minnesota Planning Board of the State of Minnesota.

PROPOSED DESCRIPTION PARCEL B

That part of the Northeast Quarter of Section 27, and that part of the Southeast Quarter of the Southeast Quarter of Section 22, Township 116, Range 25, Carver County, Minnesota, described as follows:

Commencing at the southwest corner of said Northeast Quarter of Sectior 27; thence on an assumed bearing of North 90 degrees 00 minutes 00 seconds East along the south line of said Northeast Quarter a distance of 462.60 feet; thence North 00 degrees 13 minutes 56 seconds East, parallel to the west line of said Northeast Quarter a distance of 1164.70 feet to the point of beginning of the land to be described; thence North 00 degrees 13 minutes 56 seconds East along said parallel line a distance of 860.00 feet; to the southerly right of way line of State Highway No. 5; thence North 60 degrees 07 minutes 15 seconds East along said southerly right of way line a distance of 789.59 feet; thence continuing northeasterly along said south line on a tangential curve concave to the south, having a wadius of 15136.97 feet; a central angle of 02 degrees 23 minutes 43 seconds, a distance of 632.80 feet to the intersection with a line parallel to the west line of said Northeast Quarter of Section 27 and passes through a point hereinafter referred to as "Point A"; thence South 00 degrees 13 minutes 56 seconds West parallel to said west line a distance of 844.71 feet to said "Point A"; thence South 60 degrees 07 minutes 15 seconds West a distance of 1429.87 feet to the point of beginning
