At scheduled intervals, this office reviews files not in hearing status that have been pending for awhile to determine their progress towards review. ***The above-referenced petitions were received on July 3, 2000 and both files have been pending for over a year.*** Any ordinance for annexation enacted pursuant to Minnesota Statutes Chapter 414 is not final or effective until approved by this office.

Docket A-6338: Our staff was advised, several times, that the petitioner would withdraw the petition and resubmit the necessary documentation. No request for withdrawal has been received. Please resolve this matter within thirty days. After which, we will assume the City is no longer interested in annexing this area and take action to close the file. (Please note: It appears that this area is included in the petition received on October 27, 2000, MBA Docket A-6387).

Docket A-6339: The City was advised on or about August 4, 2000, that the legal description for this proceeding was approved by MNDot Cartographics, qualifying it as ready for the review agenda. This matter could be brought to the Director of Minnesota Planning for consideration as soon as the ordinance and \$100.00 filing fee are received. If the ordinance and the filing fee are not received in thirty days, we will assume the City is no longer interested in annexing this area and take action to close the file.
