WAIVER OF OBJECTION TO ANNEXATION

WHEREAS, a certain Petition requesting annexation of the territory located in the County of Isanti, State of Minnesota, described as follows, to-wit:

The West Half of the Northwest Quarter (W $\frac{1}{2}$ of NW $\frac{1}{4}$) of Section Twelve (12), Township Thirty-seven (37), Range Twenty-three (23), excepting therefrom the following described tract of land, to-wit:

Commencing at the northeast corner of the NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of said Section 12, Township 37, Range 23; thence south along the 40 line a distance of 44 rods; thence west and parallel with the north line of said NW $\frac{1}{4}$ of NW $\frac{1}{4}$ a distance of 2 rods; thence north and parallel with the east line of said NW $\frac{1}{4}$ of NW $\frac{1}{4}$ a distance of 7 rods; thence east a distance of 13 feet; thence northeasterly to a point on the north line of said NW $\frac{1}{4}$ of NW $\frac{1}{4}$ 10 feet west of the northeast corner of the NW $\frac{1}{4}$ of NW $\frac{1}{4}$; thence east along the north line of said NW $\frac{1}{4}$ of NW $\frac{1}{4}$ to point of commencement. Also excepting that part of the W $\frac{1}{2}$ of NW $\frac{1}{4}$ of Section 12, Township 37, Range 23, described as follows:

Beginning at the northwest corner of said W $\frac{1}{2}$ of NW $\frac{1}{4}$; thence easterly along the north line of said W $\frac{1}{2}$ of NW $\frac{1}{4}$ a distance of 275.00 feet for the actual point of beginning of the parcel to be herein described; thence southerly and parallel with the west line of said W $\frac{1}{2}$ of NW $\frac{1}{4}$ a distance of 475.37 feet; thence easterly and parallel with said north line a distance 275.00 feet; thence northerly and parallel with said west line a distance of 475.37 feet to said north line; thence westerly along said north line a distance of 275.00 feet to the actual point of beginning.

Subject to County State Aid Highway No. 4 over the north 33.00 feet thereof.

was duly served upon the Stanchfield Township Clerk; and

WHEREAS, said Petition for Annexation was duly considered by the governing body of Stanchfield Township in Isanti County; and

WHEREAS, after consideration, the governing body of Stanchfield Township has determined that the annexation of the above described property is in the best interests of Stanchfield Township, Isanti County, and Stanchfield Township has no objection to the annexation of the above described property by the City of Braham.

NOW THEREFORE, be it resolved by the Stanchfield Township Board of Supervisors as follows:

1. That the Stanchfield Township Board of Supervisors waives any objection to the annexation of the above described property by the City of Braham and that it is deemed in the best interests of the city of Braham and the best interest of the above described property that said property be annexed by the City of Braham.
2. That the ninety-day period within which Stanchfield Township may file written objections to said annexation as provided for in Minnesota Statutes, § 414.033, Subdivision 5, is hereby waived.
