

ORDINANCE No. 00-06

AN ORDINANCE ANNEXING TO THE CITY OF WINSTED, MINNESOTA CERTAIN LANDS IN WINSTED TOWNSHIP ABUTTING THE CITY OWNED BY NORTHERN STATES POWER COMPANY, A MINNESOTA CORPORATION.

THE CITY COUNCIL OF WINSTED DOES ORDAIN:

Section 1. The City of Winsted has received the Petition to annex certain lands to the City of Winsted by NORTHERN STATES POWER COMPANY, A MINNESOTA CORPORATION, hereinafter referred to as NSP. The land which Petitioner is requesting to be annexed to the City of Winsted is as stated in Exhibit "A" attached hereto and incorporated herein by reference as though fully set forth in full. All of said lands abut upon the present territorial limits of the City of Winsted. The City Council of the City of Winsted desires to annex such lands so as to include said lands within the City of Winsted, County of McLeod and State of Minnesota and to further adopt an Ordinance annexing said lands to said City of Winsted. Said parcels of land are currently located in Winsted Township, McLeod County, Minnesota.

Section 2. The Mayor and the Council of the City of Winsted do hereby determine that the land referred to in Section 1 above, and legally described in Exhibit "A", abut upon the present territorial limits of the City of Winsted, are urban in character, and the annexation of said lands will be to the best interest of the City of Winsted and the territory affected.

Section 3. Therefore, the land referred to in Section 1 above and legally described in Exhibit "A", is hereby annexed, added to and made a part of the City of Winsted, as effectually as if they had originally been a part thereof.

Section 4. Both the City of Winsted, Minnesota and the Township of Winsted, Minnesota have executed Waivers of the statutory 90-day period before a City Ordinance of Annexation can be adopted.

Section 5. This Ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Board, the Clerk of Winsted Township, the McLeod County Auditor and the Secretary of State of Minnesota.

That part of the East Ten (10) acres of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Ten (10), Township One Hundred Seventeen (117) North, Range Twenty-seven (27) West described as follows to-wit:

Beginning at a point Four Hundred Twenty (420) feet South and Fifty (50) feet West of the Northeast corner of said Section, Township and Range, and running West Seventy-five (75) feet, thence South Seventy-five (75) feet, thence East Seventy-five (75) feet, thence North Seventy-five (75) feet to the place of beginning.

In addition, the following described parcel lies East of the above described premises and also lies under the right-of-way of former State Highway 261, now known as McLeod County 1 (and also is known as Sixth Street South in the City of Winsted, Minnesota):

That part of the East 10 acres of the Northeast Quarter of the Northeast Quarter of Section 10, Township 117 North of Range 27 West described as follows to-wit:


Beginning at a point 420 feet South and 50 feet West of the Northeast corner of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ of NE $\frac{1}{4}$) of Section 10, Township 117 North, Range 27 West, McLeod County, Minnesota, thence East, parallel with the North line of said Northeast Quarter, 50 feet; thence South, along the East line of said Northeast Quarter, 75 feet; thence West, parallel with the North line of said Northeast Quarter, 50 feet; thence North 75 feet to the point of beginning.

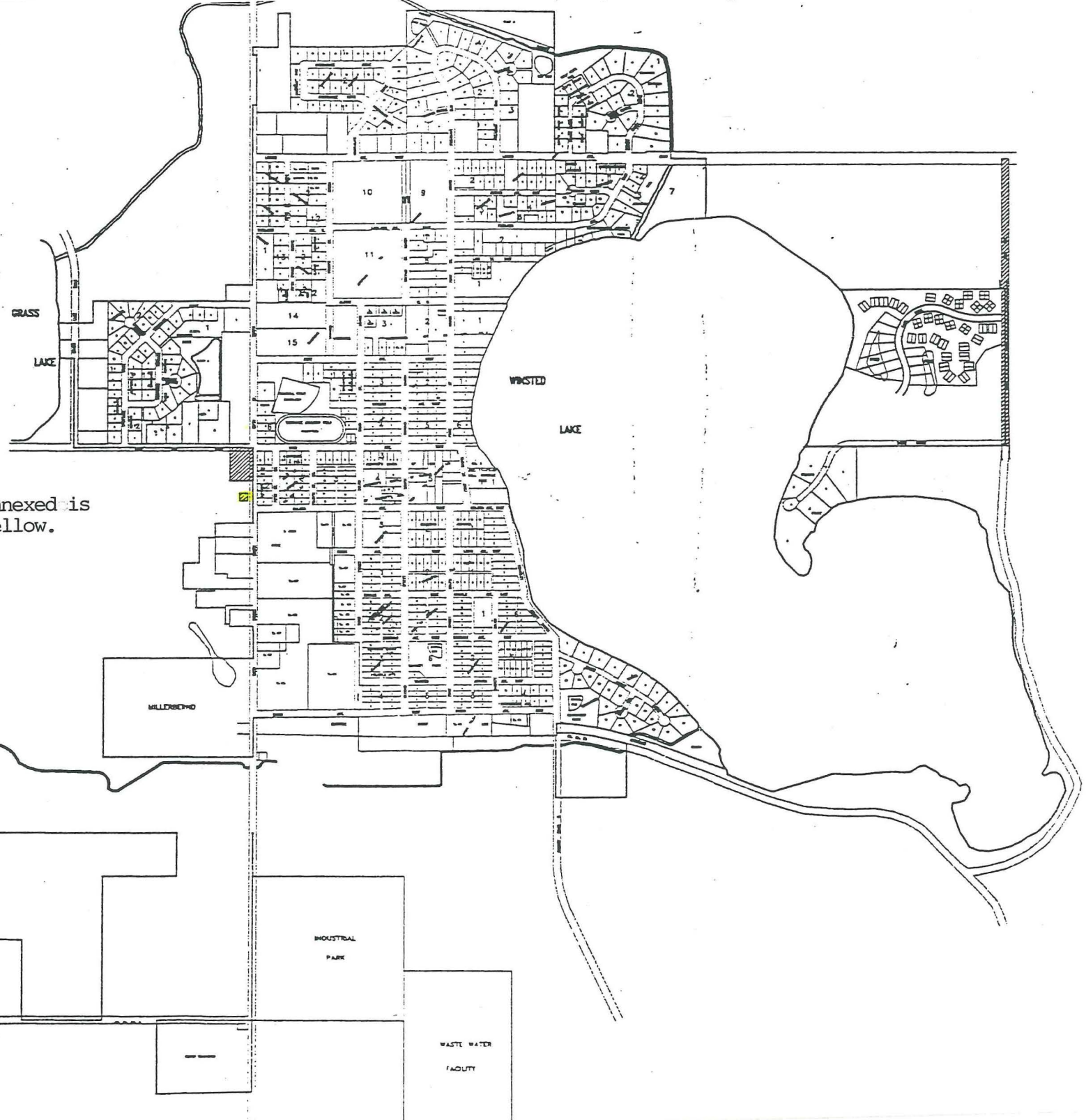
