## ORDINANCE NO. 27, 3RD SERIES

AN ORDINANCE ANNEXING CERTAIN PARCELS TO THE CITY OF INTERNATIONAL FALLS AND PLACING THE SAME WITHIN THE JURISDICTION OF SAID CITY.

THE CITY COUNCIL OF THE CITY OF INTERNATIONAL FALLS, MINNESOTA DOES ORDAIN AS FOLLOWS:

Section 1. That after due consideration, the City Council has deemed it to be in the best interest of the City that said real property, which is composed of approximately 8.23 acres, be annexed to and become a part of said City.

Section 2. The boundaries of said property to be annexed are as follows:

Beginning at a point on the South line of Lot Thirty-five (35) of Auditor's Plat Number Eleven (11) in Section Nine (9), Township Seventy (70), Range Twenty-four (24) that is Two Hundred Feet (200 ') West of the Southeast corner of Lot Thirty-five (35), said point of beginning is located on the existing City Limit Boundary; thence run West along the South line of Lot Thirty-five (35) to a point that is Thirty-three Feet (33') from the Southwest corner of Lot Thirty-five (35); thence angle right and run parallel with and Thirty-three Feet (33') from the West line of Lot Thirty-five (35) and Lot Five (5) to a point on the North line of Lot Five (5); thence angle right and run on the North line of Lot Five (5) to a point that is Two Hundred Feet (200') from the Northeast corner of Lot Five (5), said point being located on the existing City Limit Boundary; thence angle right and run parallel with and Two Hundred Feet (200') from the East line of Lot Five (5) and Lot Thirty-five (35) along the existing City Limit Boundary to the said point of beginning on the South line of Lot Thirty-five (35) and there terminating.

Section 3. That accordingly Lot Five (5) and Lot Thirty-five (35) of Auditor's Plat Number Eleven (11) in Section Nine (9), Township Seventy (70), Range Twenty-four (24), less the East Two Hundred Feet (200') and less the West Thirty-three Feet (33') of each said lot be and is annexed to the City of International Falls and that said tracts of land hereby are a part of and subject to the jurisdiction of the City of International Falls, Minnesota, and is Zoned R-2B Residential in accordance with the City Code.

Section 4. City Code Chapter 1 entitled "GENERAL PROVISIONS AND DEFINITIONS APPLICABLE TO THE ENTIRE CITY INCLUDING PENALTY FOR VIOLATION", and City Code Section 1.99, "VIOLATION A MISDEMEANOR", are hereby adopted by reference as though repeated verbatim herein.
