



ORDINANCE NO. 50

**AN ORDINANCE ADJUSTING THE BOUNDARIES  
OF THE CITY OF BIWABIK, MINNESOTA, PURSUANT TO  
MINNESOTA STATUTES, SECTION 414.033**

The City Council of the City of Biwabik, Minnesota, hereby ordains as follows:

**SECTION 1**

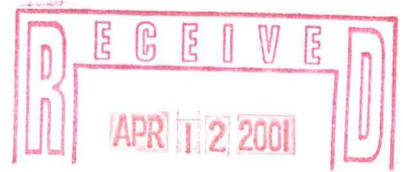
*WHEREAS*, on November 14, 2000, the City Council of the City of Biwabik, Minnesota, at a duly convened meeting did pass a Notice of Intent to Annex by ordinance approximately 11.5 acres of land owned by the City of Biwabik and located within the Town of White, said Notice being authorized pursuant to Minnesota Statutes, Section 414.033; and

*WHEREAS*, said Notice of Intent to Annex by ordinance was filed with the Minnesota Office of Strategic and Long-Range Planning and was served upon the Town of White by letter dated November 21, 2000; and

*WHEREAS*, the Town of White has not filed any objections with the Minnesota Office of Strategic and Long-Range Planning and, in fact, has waived any such objections and agreed to allow the City of Biwabik to annex said 11.5 acres by ordinance, said waiver being adopted by the Town Board of the Town of White on February 1, 2001; and

*WHEREAS*, the City of Biwabik, Minnesota, does wish to proceed with the annexation of said 11.5 acres by ordinance.

**SECTION 2**

The City Council of the City of Biwabik, Minnesota, at a duly convened meeting on the 12th day of March, 2001, does hereby adopt an ordinance adjusting its boundaries so that included in its boundaries is the following described real estate:

Government Lot Three (3) in the Northwest Quarter of Northwest Quarter (NW<sup>1</sup>/<sub>4</sub> of NW<sup>1</sup>/<sub>4</sub>), Section Twelve (12), Township Fifty-Eight (58) North of Range Sixteen (16) West of the Fourth Principal Meridian;

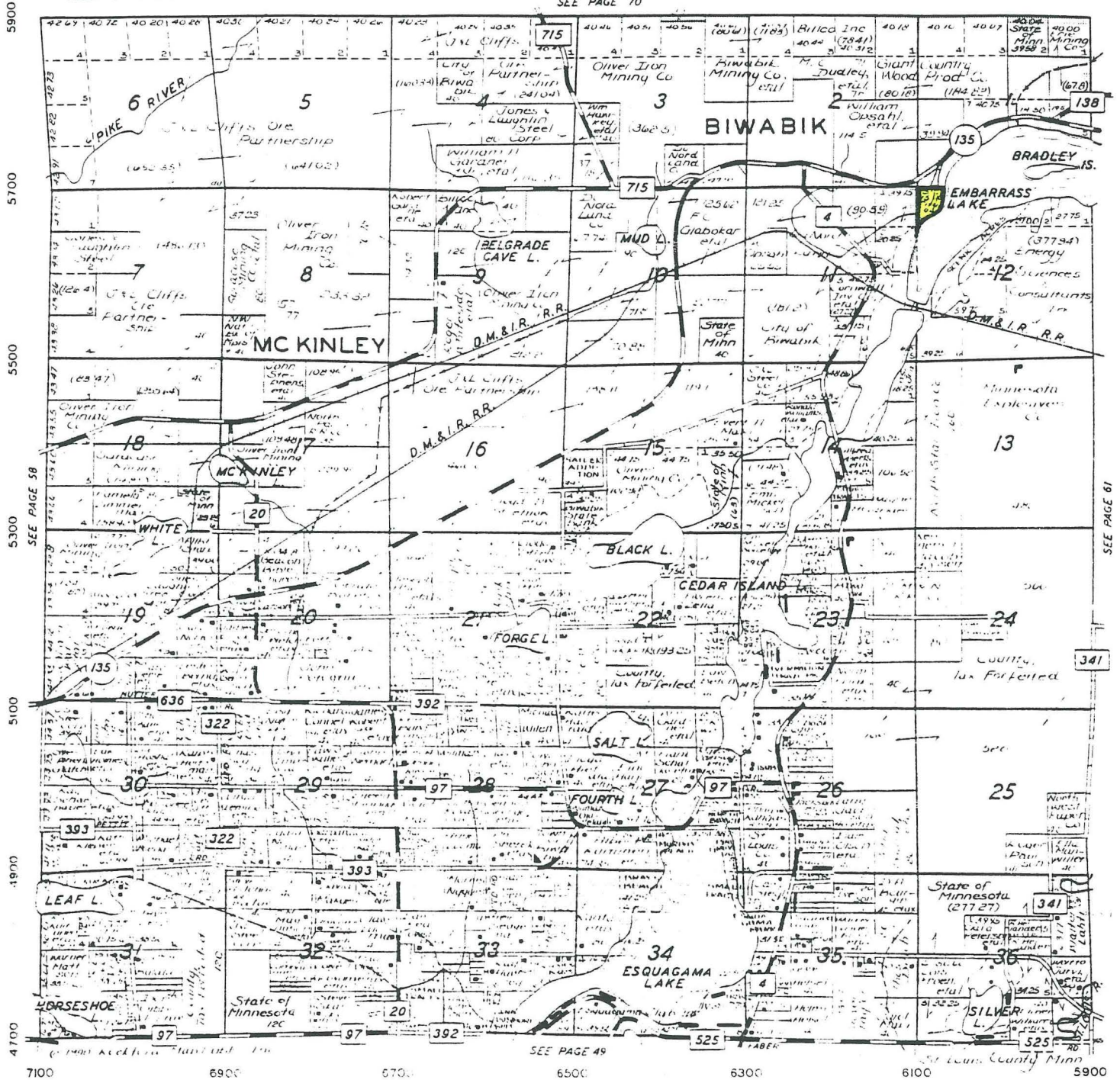
