

ORDINANCE NO. 2000-09

**AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF
GRAND MARAIS TO INCLUDE CERTAIN UNINCORPORATED TERRITORY
(BORDERED BY LAND WITHIN THE CITY LIMITS)**

WHEREAS, Certain territory described in the Attached Exhibit A-3 is not presently included within the corporate limits of any incorporated city or borough; and

WHEREAS, 60 percent or more of the perimeter of this territory is bordered by lands already within the corporate limits of the city and is deemed to be or is about to be urban or suburban in character;

The city council of the City of Grand Marais, Minnesota, ordains:

Section 1. Territory annexed. The corporate limits of the city of Grand Marais, Minnesota, are hereby extended to include the unplatted territory described in the attached Exhibit A-1, 60 percent or more of the perimeter of which territory is bordered by territory already included within the city limits.

Section 2. Filing. The city clerk-Treasurer is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Cook County, the county in which the property is located, Minnesota Municipal Board.

Section 3. Population. The population of the annexed territory is zero (0).

Section 4. Effective date of annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2 and approval by the Minnesota Municipal Board

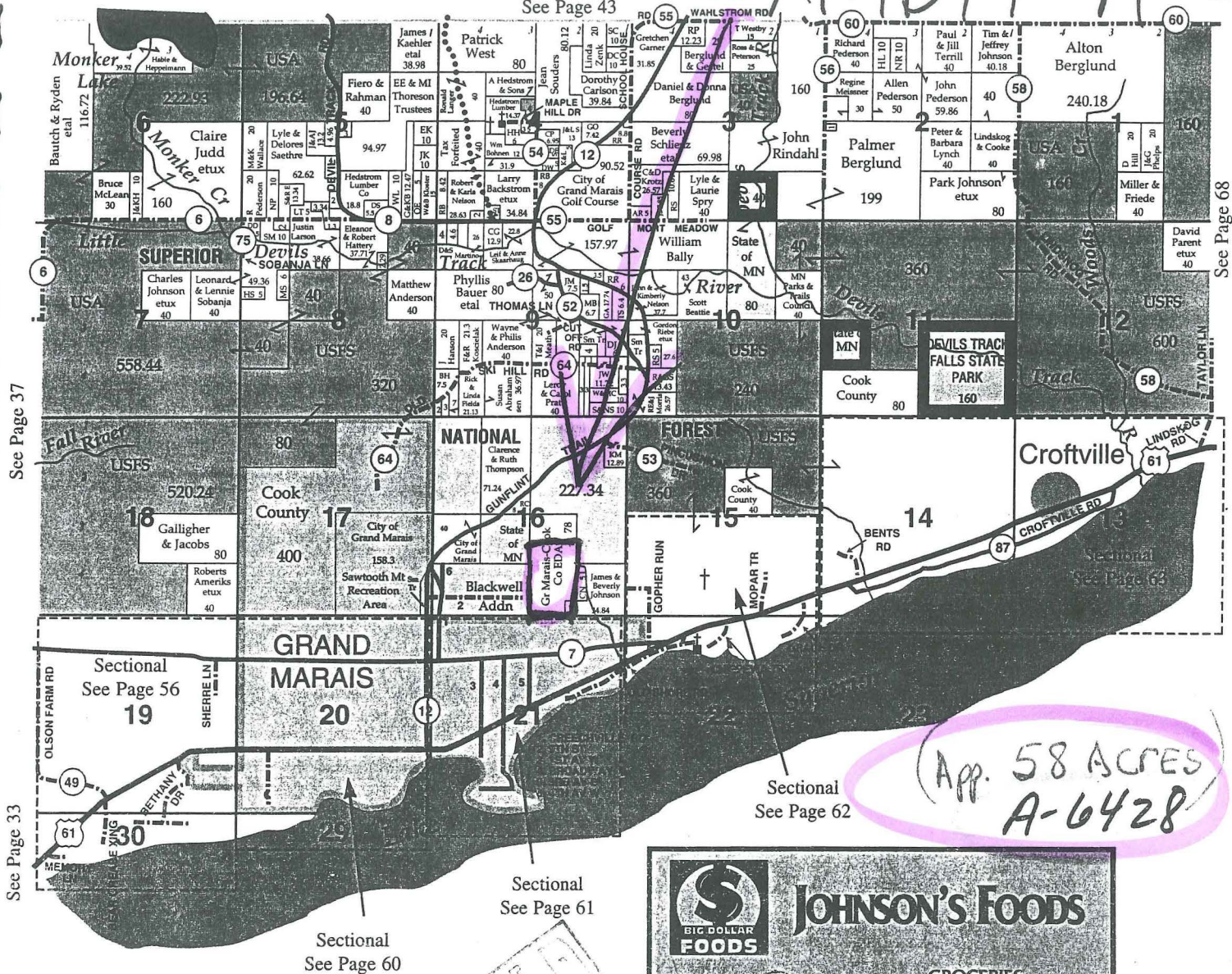
