## **ORDINANCE NUMBER 238**

## AN ORDINACE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WABASSO TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY THE CITY OF WABASSO AND ABUTING UPON THE CITY LIMITS

WHEREAS, the real estate described below is not presently within the corporate limits of any incorporated city; and

WHEREAS, the real estate abuts upon the corporate limits of the City of Wabasso at the East boundary, is presently agricultural in character and is vacant, and consists of approximately 19.5 acres, and

WHEREAS, this real estate is owned in fee by the City of Wabasso and is about to become urban or suburban in character and the annexation is required to protect the public health, safety and welfare and is in the best interests of the property proposed for annexation;

THE CITY COUNCIL OF THE CITY OF WABASSO, MINNESOTA ORDAINS:

<u>SECTION 1.</u> Real Estate Annexed. The corporate limits of the City of Wabasso are hereby extended to include the unplatted property described below, now owned by the City:

The North 625 feet of the South 1678.37 feet of the West 824.00 feet of the Southwest Quarter of Section 24, Township 111, Range 37, Redwood County, Minnesota, Excepting therefrom FRERICKS ADDITION as platted and of record in the office of the County Recorder said Redwood County, Minnesota,

## AND

The South 1053.37 feet of the West 824.00 feet of the Southwest Quarter of Section 24, Township 111, Range 37, Redwood County, Minnesota, Excepting therefrom the Westerly 398.00 feet as measured along the southerly line of said Southwest Quarter of Section 24.

<u>SECTION 2.</u> Filing Certified Copies. The City Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of Redwood County, the Town Clerk of Vail Township, and Minnesota Planning-Minnesota Boundary Adjustment.


SECTION 3. Effective Date of Annexation. This Ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2.




