- 1. The territory to be annexed consists of .14 acres, .36 acres, and .38 acres of unplatted lands, lying entirely within St. Mary Township in the County of Waseca, Minnesota, and a description of such lands are contained in Exhibit "A". Said land is to be zoned R-2, Urban Residential District.
- 2. The territory to be annexed is owned by Robert J. and Jeanette C. Byron.
- 3. The territory described above abuts the City's southern and western borders, adjacent to 120th Street.
- 4. The territory described is urban or suburban in nature or about to become urban or suburban in nature, and is planned for Urban Residential development.
